Mr. Bilyeu stressed that the time element is crucial, it is a large upgrade financially and in scope; pros and cons were discussed and clarified. Judge Self stressed that he is uncomfortable with this Change Order unless a maximum amount notation can be added. Bill Burke, Special Projects, was asked to comment. Commissioner Cole motioned to go ahead as the commitment has been made to the new court house so the need is to move ahead. Commissioner Hatchell also stated he wants a set maximum change amount. Commissioner Cole commented on a proposed bill that states transcripts from court actions belong to the citizens of the county rather than the individual court reporter. Discussion followed; Commissioner Hoagland stressed support for this. Bill 516 was also discussed, covering commissioners courts ability to hire attorneys. Rodney Rhoades, Budget Director, had prepared a list of numerous bills covering various issues. Mr. Rhoades explained that his office will track and monitor these, giving updates and information to the Court as they move through the legislative process, and identify the ones that are moving quickly or ones that would have an adverse effect on Collin County. One area, for example, that Mr. Rhoades is looking at for legislative change is court appointed interpreters: he will get information, as it is available, will report back. A discussion followed about electronic court reporting at the district court level. Judge Self stated he felt they should pass this resolution, letting the state legislators know this is what Collin County wants: but, it would ultimately be up to the legislators to approve and pass it, but it is important to alert them to the County's desires. The Commissioners discussed the future District Courts here in Collin County and Judge Self said that his understanding is that the first new District Court for Collin County will be appointed October of 2007 and the second one will be filled by election by the 2008 primary and general election, taking effect January 1, 2009. Commissioner Cole expressed some reservations about the new District Court set up. Commissioner Hoagland agreed and suggested further discussion. Commissioner Hoagland made a motion that Judge Self would contact Representative Ken Paxton to hold the bill and post this on the agenda for the March 27, 2007, Commissioners Court, thus holding on this resolution for the moment. This time frame will work as the bill filing deadline is March 9, 2007. Commissioner Cole seconded the motion, and it passed with a 5-0 vote of the Court. (Time: 10:34:20 a.m.)
