that specializing would require criminal cases be tried first. Judge Self said it was not fair to law-abiding citizens that need their time in court for daily life decisions. The local judges have told Judge Self they are capable of scheduling their cases without the state legislature telling them how. Commissioner Hoagland stated his belief that looking at specialization of courts should be further investigated. Judge John Roach, Jr., came before the Court to voice his opinion that specialized courts should be explored but on the local level and that flexibility would be at stake with specialization. Judge Roach also noted that specialized courts are much different than specialized dockets, which still allow for flexibility. A discussion followed among the Commissioners about the situation in general, the recent requests for Austin to choose the next district judge in the 2008 primary, and the fact that the governor may take a larger part in the choice of judge. Commissioner Hoagland made a motion to make a specialized court and to make Judge Roach's court a specialized civil court. The motion died for lack of a second. (Time: 9:20:41 a.m.)

<u>Item No. 5</u> Al-26336 Consideration, discussion and any action regarding the development of a broadcasting and webcasting project, Public Information. Leigh Hornsby, Public Information Officer, addressed the Court with an abbreviated presentation from the previous Workshop session concerning the choices of broadcasting or webcasting of Commissioners Court. The Commissioners discussed the pros and cons of each choice: first, live webcasting with complete broadcasting; second, complete recorded broadcasting and webcasting; and third, an inter-local agreement to broadcast with the City of McKinney. The second choice was favored due to the more modest cost and the fact that equipment could be easily retrofitted into the new facilities without a huge expense. Judge Self clarified that the request was not to actually go out and buy the equipment at this time but the request is to get the go ahead to seek bid requests. Commissioner Hoagland motioned for option two, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. Frank Ybarbo answered the Court's question concerning the timeframe that it is about a six week endeavor, evaluation to bid to award. (Time: 9:35:31 a.m.)

Item No. 6 Consideration, discussion and any action regarding legislative items for the upcoming 80th Legislative Session, Commissioners Court. Judge Self wanted to discuss the resolution removing CSSB 792 and 965, the two amendments concerning the NTTA, North Texas Toll Association. The commissioners discussed this situation but no motion was made in support, so the resolution died. (Time: 9:29:22 a.m.)

Judge Self spoke about going to Austin to testify before the Sub-Committee of Public Health Committee; they would be considering six bills. Judge Self was going in order to tell them: 1. Collin county wants to take care of its own indigent population, and 2. a system is in place to take care of indigent health care needs, and 3. another proposed addition to that system is about to take place which will more fully meet these needs. Discussion followed among the Commissioners

Commissioner Hatchell wanted to discuss a resolution endorsing Motor Fuels Tax Indexing, stating the Court had been fighting for this through the last 2-3 legislative sessions. Commissioner Hoagland made a motion to adopt the resolution with an added provision that the gas tax in its entirety be devoted to construction or maintenance of the state highway system and all diversions put back; Commissioner Jaynes seconded, and the motion passed with a 4-0 vote of the Court. (Time: 9:58:39 a.m.)
