Item No. 6 Al-26209 Consideration, discussion and any action regarding the adoption of the amended Tax Abatement Policy, Budget (Held from February 27, 2007). Rodney Rhoades, Budget, stood before the Court stating that a copy of the proposed tax abatement policy was sent to the four cities of Allen, McKinney, Plano, and Frisco, asking for their input and that he had not received any response. Mr. Rhoades went over the possible options and his staff's recommendations; Court discussion followed with possible recommendations concerning smaller cities. Commissioner Jaynes stressed he did not want to have

a policy that is constantly being amended for some cities. The Court decided more thought needed to go into this policy and held it for further discussion. (Time: 9:35:49 a.m.)

HELD

<u>item No. 7</u> Al-26443 Consideration, discussion and any action regarding potential funding sources for transportation projects related to Pass Through Financing, Budget. Rodney Rhoades, Budget, led the discussion on ways to finance transportation projects using current dollars that are available to the County. Mr. Rhoades brought projects to the Commissioners attention that are not currently under construction or are stalled or are not yet designed. Judge Self condensed the subject to the pertinent facts and explained that this is simply a method to use currently available monies. Judge Self also noted that no action is required at this time but that the Court needs to be thinking about it as it is a good use for County money that is in-hand and that would require less taxes be paid later and it would get needed projects started. (Time: 9:42:52 a.m.) Mr. Rhoades returned to this topic with a handout for each commissioner, noting in detail by city, current abatements in place, vendor or company, length with start and end dates, percentage abated, total abatement value, and total annual taxes abated. Commissioner Hoagland wanted to see the number of jobs created by offering abatements that bring new business into the county. Judge Self suggested more information was needed on the chart and this motion should be tabled for the time being; Commissioner Jaynes agreed and made this motion, Commissioner Hatchell seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:57:22 a.m.)

# **MINUTES**

Item No. 8 Al-26334 Consideration, discussion and any action regarding night meetings, County Judge. It was clarified that Commissioners Court or Workshop night meetings could be moved around the county as long as public notice was posted. Due to various hardships involved in moving the Court to night meetings, the suggestion to try one Workshop per quarter for the next year was generally thought to be a good way to start. Commissioner Hoagland made the motion, suggesting Commissioner Cole go first since she is Precinct 1 and the first quarter of the year has already passed; Commissioner Cole seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:50:19 a.m.)
