Collin County Housing Finance Corporation purpose and options, Commissioners Court. Mr. Robert Johnson, First Southwest Company, presented a briefing to the Court on Housing Finance Corporations, the history and background, how they are used, and Collin County's past involvement with HFCs. Rodney Rhoades, Budget, addressed HS 1638, related to the calculation of the effective tax Mr. Rhoades reported that the new property exclusion is still in the bill; he read the current wording and the proposed wording of the bill. Discussion about SB 18 from 2005 transpired and Mr. Rhoades stated that Collin County has successfully succeeded in meeting the intent of this bill. Discussion followed concerning bills and how a companion bill can get assigned with a generic number and passed innocuously so it is important to be vigilant and watch the bills closely as they move through the legislative Commissioner Cole noted that the bill allowing JP Courts to use electronic filing had passed and she considered it an improvement.
