Tracy Homfeld, Engineering, stood before the Court and asked for approval for the re-plat, barring any negative input. Judge Self asked if there was anyone in the audience wanting to address this item; there was no response. Commissioner Jaynes motioned to close the public hearing and approve the re-plat, Commissioner Hoagland seconded, and the motion passed with a 4-0 vote of the Court. (Time: 9:17:21 a.m.)

Item No. 11 AI-26608 Consideration, discussion and any action regarding Personnel Appointments, Human Resources. Cynthia Jacobson, Human Resources, came forward and said that the first position concerning the Public Information Officer, due to years of experience, was not starting at the beginning step. The next position concerned the rehire of a former retired county employee for a part-time position. The third offer was being rescinded until additional background information could be collected. Judge Self asked questions concerning the rehire of retired personnel and how retirement pay is impacted. Commissioner Hoagland motioned to approve, Commissioner Jaynes seconded, and the motion passed with a 4-0 vote of the Court. (Time: 9:33:03 a.m.)

For instance, why is there not a 'measures of performance' report for Tex-21 since the payment is considered to be for a professional services contract. Judge Self continued by saying that with Pay-for-Performance in place for county employees, it only makes sense to have something in place for success measurement when professional services are being paid for. There was further discussion among the Commissioners. Commissioner Jaynes stated that since it is paid for the year it would be good to watch and see the performance for 2007 and then re-evaluate at year end, prior to paying dues again. Bill Bilyeu, Administrative Services, shared information he had from various entities concerning the definitive use of the census numbers for redistricting. Discussion followed concerning the best time to go through the redistricting process and what is involved. (Time: 9:46:33 a.m.)

Item No. 16 AI-26594 Consideration, discussion and any action regarding the designation of a County representative to an Architectural Design Review Committee for the Justice Center Site, Commissioners Court. Commissioner Jaynes commented that this item was something he had discussed with Commissioner Hoagland several weeks ago and more recently with Judge Self, stating it would be good to have someone looking out for the County's interests concerning construction near the new Court facilities. The desire is for a voice in the zoning and architectural style that is chosen for this land and Commissioner Jaynes suggested Bill Burke, Building Projects for the County, and Bill Bilyeu, Adminstrative Services, would be the appropriate people for the job. The goal would be to make sure the plans for the area meet the goals and standards of the City and County and that the buildings to be constructed meet the architectural style of the Courts complex. Commissioner Hoagland made the motion for Mr. Burke and Mr. Bilyeu to be on the committee, Commissioner Jaynes seconded, and the vote motion passed with a 4-0 vote of the Court. (Time: 9:52:21 a.m.)

COURT ORDER NO. 2007-450-05-22

Consideration, discussion and any action regarding legislative items for the 80th Legislative Session, Commissioners Court. Rodney Rhoades. Budget Director, briefed the Court on the latest legislative items of concern, including HB 1892 and HB 792. Discussion between Mr. Rhoades and the Court followed concerning various legislative issues, what they entail, the possible intent, and various ramifications. There was in-depth discussion about the various items and the effect on county roadway construction and funding. Ruben Delgado. Engineering, was also asked to share his insights with the Court. Judge Self asked Bill Bilyeu and Commissioner Hoagland to confer during the recess and prepare a resolution for the Court's signature to send to the County's legislative representatives expressing disfavor with any Collin County funds going anywhere outside of Collin County to subsidize road construction. (Time: 9:54:58 a.m.) After their return from Executive Session, Commissioner Jaynes started the discussion saving he would have to vote against a new resolution, saying he felt the Commissioners had already made their feelings clear, that no one wants to see SH 121 become a 'Robin Hood' Tollway and that this is too late an hour to send a new Commissioners Court Minutes May 22, 2007 Page 9 of 10

resolution and it could come back 'to haunt us' later. Commissioner Cole agreed with Commissioner Jaynes. Judge Self said he agreed with Commissioner Hoagland and Commissioner Cole's earlier comments that this Court is not in charge of this process, the County is not being allowed to make the decisions, and has little authority concerning this. He also stated he thinks the Court made their position clear early on in the Cintra and NTTA processes; saying Collin County needs to now build relationships within the NTTA and RTC and to make the best situation possible. However, Judge Self stated that if Commissioner Hoagland wanted to make a motion, a vote would be taken. No motion was made. (Time: 10:43:11 a.m.)
