Election Day for the legal sale of all alcoholic beverages for off-premise consumption only, Elections. Sharon Rowe, Elections, came before the Court and emphasized that the election represented in this item is different than the norm. This is a prohibition-type, local option election for legalization. The measure is stated exactly the same and you discern the difference through the petition process. The required number of signatures was 261 and 272 of them have been accepted as valid for petition. Commissioner Hatchell motioned to approve, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:26:17 a.m.)

Item No. 6 Al-26839 Consideration, discussion and any action regarding ratification and extension of the County Judge's prior approval of a Declaration of Disaster as the result of severe storms, flash flooding, and flooding that began May 23, 2007, Fire Marshal. Judge Self explained that June 29, 2007, Governor Perry added Collin County to his Disaster Declaration. Judge Self delayed Collin County's Disaster Declaration until July 3, 2007, so that this Court meeting would be one week after in order for ratification. Judge Self recognized the Emergency Management Team saying they had done a great job: As a result of their hard work, Steve Deffibaugh, Fire Marshall, John Kleinhexsel, Public Works, and others, Collin County met the minimum standard to qualify for the public assistance should a State of Disaster be declared. Commissioner Jaynes motioned to ratify the decision to declare a disaster in Collin County, Commissioner Hatchell seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:29:12 a.m.)

Ms. Jacobson went on to explain that because only a small group of departments can be added to PFP yearly, there is still a small portion that are not yet PFP active. They are, however, scheduled to be added over the next two years; in the meantime, these employees receive merit pay. The remainder of the Sheriff's office and constables, District Clerk's office and district courts, and county courts at law are the remaining groups that will be participating by 2009. Commissioner Hatchell motioned to approve, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:30:47 a.m.)
