Awaiting Bill Bilyeu's, Administrative Services, research on the issue and a legal opinion, Judge Self stated that with the agenda listing the backup documentation under Executive Session, it would either be discussed in Executive Session or tabled; but his preference would be to err on the side of openness. <u>Item No. 20</u> Consideration, discussion and any action regarding recommendations presented by the 2007 Bond Committee:

1. Transportation. Ruben Delgado, Engineering, gave the background on the Committee, stating that Carter & Burgess was the engineering consulting firm used.

Robbie Robinson, committee chair, went forward to make the committee's presentation. Mr. Robinson thanked the committee, noting there were 37 members; the county and city support staff; and Carter & Burgess Engineering Consulting Firm. Mr. Robinson covered the Committee's purpose, history and scope, and recommendations. Mr. Robinson addressed what the Committee had been asked to evaluate and the conclusions that were drawn, stating that the Committee's recommendations had received 100% support of its members.

The Transportation Bond Committee recommended a transportation bond program of \$235.6 million. It was noted that this figure is 18% higher than the guideline. The Committee felt that the transportation issues of Collin County were of a critical nature.

2. Open Space.

Colleen Eagan, committee member, came forward representing the Open Space Bond Committee. Ms. Eagan thanked the members and support staff and commented on the committee's process, meeting habits and background, and scope.

The Open Space Bond Committee recommended an open space bond program of \$17 million. Ms. Eagan stated that

> there were no specific list of projects, other than the Six Cities Hike and Bike Trail system; she noted that a list would create itself as city requests came in, but the committee saw more parks and additional trails being created.

3. Facilities.

Bill Moore and Bill Mills, co-chairs for the Facilities Bond Committee, went forward to give the presentation. Mr. Moore and Mr. Mills thanked the committee members, discussing their work habits, methodology, and meeting schedule. The Committee had a list of needs and then evaluated and prioritized the specific projects.

The Facilities Bond Committee recommended a facilities bond program of \$76.4 million and outlined a master plan of the projects and a timeline for the work on each.

4. Presentation.

Family Violence Task Force regarding the Family Violence Justice Center, Commissioners Court. Rebecca Egleston-Caso of the Family Violence Council came forward and gave a presentation advocating the creation of a Collin County Family Justice Center. The desire is to create a facility where all the involved parties would be housed to take care of the victims of family violence--from the district attorney and sheriff's representatives to the agencies that assist the victims.

Public Comments: David Dorman, Melissa, and Sharon Easley, Plano, both stood and made comments concerning the Family Violence Justice Center.
