Item No. 5 AI-26963 Discussion and any action regarding the distribution and purchase scanners for the CIJS (Common Integrated Justice System) - Civil/Family/Juvenile phase only utilizing the Texas Cooperative contracts for competitive pricing (total cost NTE \$180,740), Information Technology. Caren Skipworth, Information Technology, explained that the Court Technology Committee met on July 25, 2007, to discuss the CIJS project and to come up with a recommendation for Commissioners Court of a scanning solution for the civil phase only which has a go-live date of November 5, 2007. Ms. Skipworth further explained that there are three phases to the Odyssey application: Civil, Criminal, and Juvenile. Judge Self questioned the requested number of scanners; Ms. Skipworth explained the committee's reasoning. Commissioner Hoagland motioned to approve the item as presented, Commissioner Cole seconded, and the motion passed with a 5-0 vote of the Court. (Time: 9:13:08 a.m.)
