**Item No. 3** Al-27225

HB 530 and Drug Court Program, Judge Ray Wheless, County Court at Law 4. Judge Wheless gave the historical background on drug court and the current status per federal mandate which will require counties 200,000 in population to formally approve a Judge Wheless is asking the county program. Commissioners Court to allow the formal drug court, if approved, to operate out of his court since he is already handling the more serious DWI violations The goal of HB530 is to cut down on the number of DWI offenders passing through the traditional jail system in favor of other options to reserve the jail space for more serious offenders. There are federal monies available to fund this Drug Court Program and it would not be a cost to the County. Questions were asked and John Hughes, CSCD, was asked for his answered. input as funding for his department would be cut by the State if the County does not adopt the Drug Court Program. Low-Income Vehicle Repair Assistance, Retrofit and Accelerated Vehicle Retirement Program (LIRAP), the Texas Emissions Reduction Plan (TERP) and Local Initiative Projects by the North Central Texas Council of Projects. Governments (NCTCOG), Special Special Projects, introduced Shannon Durham. Stevenson and Jason Brown, NCTCOG. Ms. Stevenson gave the presentation, an overview of LIRAP, with explanations of the data presented and answered the Court's questions. Judge Self asked about the collected funds and what would become of them if the County did not sign the new agreement. Ms. Stevenson stated that possibly the funds would be appropriated for use in a different county. Stevenson stressed that there is not a formal commitment to the program by simply stating an interest by the November 1, 2007, deadline; it merely starts the process. Ms. Stevenson also reiterated that the NCTCOG would be there to assist and help in all aspects of the process. Judge Self said if there were no objections he would make contact in order to move forward; there were no objections. (Time: 1:55 p.m.)

Records Management System (RMS) for Collin County, Information Techology. Caren Skipworth, I.T., gave an overview of the RMS system which is the County's current manner for managing all electronic records. Ms. Skipworth stated that the County needs a new system to enable more consistent retention and implementation; one that would take up less space, (electronic preservation rather than paper); and one that would enhance the availability of public records access. Ms. Skipworth noted currently County record keeping is a fragmented process and it would be more optimal to have all of the County's records in one location, preferably under the oversight of Margaret Anderson, the Records Supervisor.
