GENERAL DISCUSSION

Item No. 5 Al-27482 Public Hearing — Consideration, discussion and any action regarding Taxation of Personal Property in Transit, Administrative Services. Judge Self opened the Public Hearing, there were no blue cards indicating speakers for this item nor did anyone indicate from the gallery that they wanted to speak. Commissioner Hoagland asked for some details concerning this item and Bill Bilyeu, Administrative Services, addressed the Court. Mr. Bilyeu explained that it is hard to tie in a final dollar amount at this time. This situation would cover, for

example, a warehouse owned by an entity that supplies its own products and then turns over their product to another entity to avoid paying taxes on that property. Mr. Bilyeu explained that once the exemption is passed it is in place but it could be removed at a future date. Commissioner Hoagland motioned to close the Public Hearing and to approve this item for one year and then reevaluate; Commissioner Hatchell seconded, and the motion passed with a 4-0 vote of the Court. (Time: 1:38:04 p.m.)

David Halhoefen, McKinney, of Sanchez Associates, was present in support of Mr. Entrop's re-plat but he chose not to speak. Commissioners Hoadland and Hatchell stated that they were not of a mind to change the original plat. This item was moved to Executive Session for the Court to discuss with the County attorney. (Time: 1:40:31 p.m.)

On return from Executive Session, the Court readdressed the Honeycreek Farms Addition re-plat. Tracy Homfeld again addressed the Court and stated that based on local government statue 232.009 and due to 'interferring with the rights of property owners' in Honeycreek Farms Subdivision, Engineering was requesting that the Court would deny the concept plan for the Honeycreek Farms Addition. Commissioner Hoagland motioned to deny the re-plat request, Commissioner Hatchell seconded, and the motion passed with a 4-0 vote of the Court. (Time: 3:31 p.m.)

The cost would be shared among the participating cities and the County with the County's first year cost being \$2500 and approximately \$2300 each recurring year. Caren Skipworth, I.T., explained that this program is a hosted solution which means it is hosted by the vendor not Collin County and the data becomes 'cooperative' rather than 'silent' as it is now. Commissioner Cole motioned to approve, Commissioner Hatchell seconded, and the motion passed with a 4-0 vote of the Court. (Time: 2:13:29 p.m.)
