<u>Item No. 1</u> President Self convened the <u>Collin County Health Care</u> <u>Foundation</u> meeting to order at 9:02 a.m.

Item No. 2 President Self asked if any member of the Board or any member of the audience would like to have an item pulled off the consent agenda for individual consideration. Trustee Hoagland asked for item 2d to be pulled for discussion. Trustee Cole motioned to approve all but 2d on the Consent Agenda, Trustee Hatchell seconded, and motion passed with a 5-0 vote of the Board. (Time: 9:02:58 a.m.)

Trustee Cole went on to discuss page two, Exclusions under 'Lease Payments', moving to strike it from the guidelines and then approve the remainder; Trustee Hatchell seconded. Trustee Jaynes asked for clarification and Bill Bilyeu, Administrative Services, the court concerning the organizations' required reporting and county payment

It was noted that the fiscal year, not being a calendar year, has created an 'off-cycle' application request and adjudication, but this is falling within the 2006 budget allocations. Trustee Jaynes asked for the wording in the future to be stronger "in favor of the well-being of the citizens of Collin County." President Self then clarified the motion on this item to include Trustee Jaynes verbage and Trustee Cole's request to strike 'lease or rent payments' under Exclusions; the motion passed with a 3-2 vote of the Board.
