Steve Deffibaugh, Fire Marshal, requested a ratification and extension of the recent Emergency Declaration due to the ongoing threat of wildfires. Commissioner Hatchell motioned to approve, Commissioner Cole seconded, and the motion passed with a 3-0 vote of the Court.

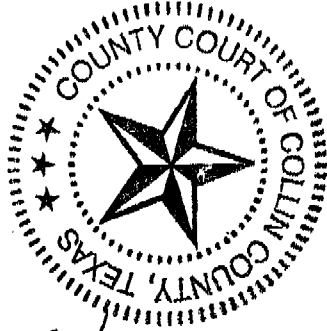
**COURT ORDER NO. 2008-078-02-05**

**Item No. 2** AI-27927 Consideration, discussion and any action to ratify and extend the County Judge's prohibition against outdoor burning in the unincorporated areas of Collin County in accordance with 352.081 of the Local Government Code, Commissioners Court. Steve Deffibaugh, Fire Marshal, requested a ratification to extend the County's prohibition against outdoor burning for a period of ninety days. Commissioner Hatchell motioned to approve, Commissioner Cole seconded, and the motion passed with a 3-0 vote of the Court.


Commissioner Cole commended Fire Marshal Deffibaugh and the Department of Homeland Security for their handling of the recent wildfires.


**COURT ORDER NO. 2008-079-02-05**

There being no further business of the Court, Judge Self adjourned the meeting at 1:39 p.m.






