Judge Self led the Invocation.

Commissioner Cole led the Pledge of Allegiance.

Commissioner Hoagland led the Pledge to the Texas Flag.

Judge Self called the Collin County Health Care Foundation meeting to order at 1:33 p.m. and adjourned at 1:35 p.m.

Judge Self convened the Collin County Commissioners Court meeting Item No. 1 at 1:35 p.m.

FYI NOTIFICATION

Collin County Take Home Vehicles, Public Works. Commissioner AI-28232 Hoagland stated the County had 75 vehicles that were taken home on a daily basis; 36 being unmarked and displaying non-exempt license plates. Commissioner Hoagland made a motion to not have any unmarked automobiles with the exception of undercover vehicles. Commissioner Cole stated she would like to see those vehicles addressed on an individual basis. Jon Kleinheksel, Public Works, stated he could return to Court within 30 days with a list providing justification for the vehicles from elected officials. Commissioner Hoagland withdrew his motion. Commissioner Hoagland motioned not to approve. Commissioner Jaynes stated it was not the employee's fault that the manual was misinterpreted. Judge Self stated the motion died for lack of a second. Commissioner Cole moved to approve, Commissioner Jaynes seconded, and the motion passed with a 3-1 vote of the Court. Commissioner Hoagland voted no. (Time: 1:54:54 p.m.)

GENERAL DISCUSSION

Item No. 5 AI-28242 Presentation, discussion and any action related to the intersection at SH 121 and Exchange, Engineering. Ruben Delgado, Engineering, stated NTTA is asking Commissioners Court, and the cities of McKinney and Allen to take a lead role in advocating a better design at Exchange Parkway and SH 121. Mr. Delgado added the following reasons that make this an economic development issue: improved mobility connecting Allen and McKinney and better land use for both cities. Dennis Satre, Design Manager, Halff Associates, showed the Court a PowerPoint presentation outlining a proposal from NTTA for a design change for SH 121 to go over Exchange Parkway as opposed to Exchange Parkway going over SH 121. Commissioner Hoagland asked Mr. Satre about the cost of this project. Mr. Satre replied the estimated cost is \$9,000,000, in addition to the improvements already planned. The PowerPoint continued, with questions and answers back and forth. Judge Self asked if there was a traffic study; Mr. Delgado answered no. Commissioner Jaynes asked why this is necessary. Mr. Satre replied capacity, this will allow a 40% to 50% reduction at the intersection. Mr. Satre continued with the PowerPoint presentation, stating the Arts of Collin County will be located at the

southwest corner of the intersection on approximately 100 acres. Commissioner Jaynes asked John Baumgartner, City of Allen Engineer, the City of Allen's opinion of this project. Mr. Baumgartner replied the City of Allen believes from an accessibility perspective, SH 121 going over Exchange Parkway provides better access to areas immediately adjacent to the interchange. The Arts of Collin County has supported this all along. Mr. Satre concluded by saying the SH 121 project is scheduled to open October 1, 2009; the Exchange Parkway and SH 121 interchange will open either that same day or within a couple of months. Commissioner Jaynes moved to approve, Commissioner Hoagland seconded, and the motion passed with a 3-1 vote of the Court. Judge Self voted no. (Time: 2:27:56 p.m.)

Commissioner Cole was in favor of a Salary Advisory Committee; however, did not think the County Judge should be the Chairman of the Committee. Judge Self continued, saying the Court has asked for input from Human Resources, Budget and IT. Additionally, any Commissioner who so chooses may add input to the opinion request. Commissioner Hoagland asked Don Cozad, County Auditor, for his objective in asking for this opinion request. Mr. Cozad came before the Court and stated the intent was to assist his office in audit systems controls; he was concerned that functions could be altered and changed back with no history. Commissioner Hoagland stated Mr. Cozad was "making a mountain out of a molehill". Commissioner Hoagland did not want to diminish the authority of the IT Department. Commissioner Cole agreed with Commissioner Hoagland, adding that there have been extensive meetings on this topic. Mr. Cozad stated he was ordered by the Board of District Judges in at Budget Meeting in December 2007 to get the AG's opinion. Mr. Cozad added that he wanted "view only access", not direct access. Judge Self concluded by saying it was agreed that the Commissioners Court and Commissioners Court staff would have a chance to have input. (Time: 3:30:16 p.m.)

<u>Item No. 14</u> Al-28238 Consideration, discussion and any action regarding Amendment No. 1 for Services: County Depository (Contract No. 07108-06) with American National Bank to extend the contract for two (2) years (per LGC Title 4, Chapter 116) and further authorize the Purchasing Agent to finalize and execute same, Auditor. Don Cozad, County Auditor, stated this is standard procedure within the depository statute which allows the Commissioners Court, County or Depository to re-negotiate after two years. After going through the process, one minor amendment was made, allowing the Tax Assessor to file electronic filings for deposits starting in October 2008. Commissioner Hoagland moved to approve, Commissioner Jaynes seconded, and the motion passed with a 4-0 vote of the Court. (Time: 3:31:31 p.m.)

Al-28197 Consideration, discussion and any action to call the election for Item No. 15 the incorporation of the City of Trinity Park, Commissioners Court. Nathan Bullard, 1802 Westgate Drive, Terrell, Texas, stated he is an importer of fireworks, and the reason he is before the Court is as a result of buying 11 acres of commercial property in the City of Lucas located just in front of Trinity Park. The City of Lucas wants to annex that property, which would be detrimental to Mr. Bullard's business. Mr. Bullard said he spoke with community leaders and the church pastor and they decided to incorporate their own city. Mr. Bullard stated he felt they met all of the requirements for incorporation. Questions and answers followed between the Court and Mr. Bullard as to the number of registered voters in the area. Bill Carmickle, Mayor, City of Lucas, stated state law required Mr. Bullard to notify the City of Lucas of their intentions. Discussion continued as to the number of registered voters. Mr. Bullard stated they would hire a city attorney to help them with taxes, roads and police protection. Commissioner Jaynes and Commissioner Hoagland stated they could not vote for this election in good faith. Judge Self moved to approve and Commissioner Cole seconded. Commissioner Jaynes and Commissioner Hoagland voted no. The motion failed as a result of a tie vote. (Time: 3:48:09 p.m.)

AI-28079 Update regarding the Current Fiscal Year and next Fiscal Year Item No. 16 Budget, Commissioners Court. Commissioner Hoagland presented the Court with a handout of their budget votes from January 2007 to present. Commissioner Hoagland itemized the Court's votes for that time period and asked Judge Self for an explanation of statements in the Judge's blog relating to budget votes. Judge Self stated the votes were for reallocation of bond funds and change orders. Commissioner Hoagland read Judge Self's blog and then asked Judge Self for his vision as it related to the list of budget votes. Judge Self stated he believed the Court needed to focus on core functions of County government: judicial and law enforcement, transportation and health care responsibilities, with transportation being the most important. Commissioner Hoagland asked Judge Self to be a team player on the Court. Judge Self replied that the Court is not a team sport; rather, it is designed for the Commissioners to represent their constituents. Commissioner Cole asked Judge Self for an example of an instance where a contract was granted without the Court going through the competitive process. Judge Self replied item f1 on today's agenda. Discussion followed among Judge Self, Commissioner Hoagland and Commissioner Cole. Commissioner Hoagland stated he was insulted by some of Judge Self's blogs. Judge Self stated he will continue to work with the Court. Commissioner Hoagland said you cannot cut the tax rate without cutting spending. Constable, stated department heads and elected officials have the best interests of the taxpayers at heart. Commissioner Cole concluded by saying elected officials, department heads and the Court have done a good job with the budget. (Time: 4:17:53 p.m.)

Consideration, discussion and any action regarding participation in the Inmate Work Program, Public Works. Jon Kleinheksel, Public Works, requested to have three employees from the Public Works Department trained to pick up inmates to participate in the Inmate Work Program. Terry Box, Sheriff, stated 80 to 90 minimum security inmates participate in the program. Mr. Kleinheksel stated the inmates could work weekends on illegal dumpsites, potholes, and could clean County vehicles.
