Ruben Delgado, Engineering addressed the court stating Plano has saved funds on other projects and re-allocated those savings to the Parkwood Boulevard project. Commissioner Cole stated she thought this was a good plan as Parkwood is an integral street in the new area Commissioner Cole moved to by the Legacy Development. approve. Commissioner Hoagland seconded. Before the final vote was taken, Judge Self asked Mr. Delgado to inform the other cities that said policy was probably no longer in effect. Commissioner Jaynes asked that we look at adding verbiage to the bond policy that if the costs go up, the County's will stay the same. Commissioner Hatchell said that with escalating costs the County should either do away with the policy or have it revised to say if it's over a certain percent the costs stay the same. Mr. Delgado agreed to update the policy and bring back it to the Court for review. The motion passed with a vote of 5-0 of the Court. (Time 1:46:30 p.m.)

Judge Self requested the minutes for the June 10, 2008 Court be changed to accurately reflect his comments regarding Miscellaneous item 11-Al 28407 in which the Court discussed negotiating fees with firms receiving the highest score for special projects. After reading the minutes, Judge Self disagreed with the verbiage used and wanted the minutes to include his indication that the selection process could be violating state law. Commissioner Jaynes stated he wanted to review the statute as it is a matter of interpretation. Commissioner Hatchell said that for professional services, the Court can select a firm based on qualifications to negotiate a contract. In those two particular cases, one firm was recommended for two projects, so the Court went with a second firm. There was nothing illegal about the process. Judge Self then stated that the firm which was selected to negotiate a contract, Jacobs Carter Burgess, could have a conflict of interest on a special district. Judge Self made a motion to approve the minutes if the changes could be made as requested. Commissioner Hoagland said he did not think the County violated any state law. Judge Self said he spoke with Jim Allison who is the most knowledgeable of state and local government code and he agreed that the Court can design the system, and form a committee to put a procedure in place to grade firms. State law says when you go with the number one then you must negotiate with that company. Commissioner Jaynes said once the "Court" goes with the number one company you must negotiate, this issue is the "committee". Judge Self then stated that is a distinction that does not seem to be in state law according to Mr. Allison. Commissioner Cole requested that Mr. Allison address the Court Further discussion followed regarding the firms to explain. recommended for the special projects. Commissioners' Hatchell

and Cole said they wanted to review the previous Court's record

before they voted. Commissioner Hoagland said this should be held until they could review and make a decision. Judge Self asked that the comments reflect his attempt to make said changes. (Time 1:55:00 p.m.)

GENERAL DISCUSSION

<u>Item No. 5</u> Al-28357 Discussion and any action regarding the effect of the District Judges longevity pay in relation to similarly tenured County Court at Law Judges per section 25.0005 of the Government Code, CCL2. Judge Jerry Lewis, County Court at

Law II addressed the court to request additional pay for County Court at Law Judges according to Senate Bill 600 which mandates how CCL Judges are paid. The state also allocated \$40,000 per Court to cover any additional expenses SB 600 incurred. Judge Lewis cited an AG Opinion from 2003, which reads if a County Level Judge is similarly situated to a District Judge that gets more, then the County Level Judge is entitled to the additional amount. In an effort to become compliant with SB 600, it was requested that the additional amount of \$4,866 each be given to Judges Jerry Lewis, Weldon Copeland and John O. Barry's salaries. Monika Arris, Budget, said she would need to amend the budget for this fiscal year to pay the additional funds because it was not previously budgeted. Commissioner Hoagland made a motion to approve the request and retro back to September. Don Cozad, Auditor, and Cynthia Jacobson, Human Resources said the County cannot retro the pay. Ms. Jacobson stated it would be better from a Human Resources standpoint to pay the money in a one time payment rather than divide it over the remaining pay periods. Judge Self asked for clarification on payment to date or for the whole fiscal year. Ms. Jacobson said the whole fiscal year. Commissioner Hoagland moved to approve, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time 2:10:43 p.m.)

COURT ORDER NO. 2008-457-06-23

Consideration, discussion and any action regarding the Item No. 6 AI-28464 adoption of a Homestead Exemption, Budget. Monika Arris, Budget, addressed the court and said this is the last Court to adopt an exemption for tax year 2008. Self asked about the 15 million dollars in expenditure funds which had been set aside. Ms. Arris said the County had just started using those funds for the Outer Loop project. Discussion followed regarding options presented to the Court. Commissioner Jaynes proposed a 5% homestead exemption with a 1/4 cent tax cut. Commissioner Hoagland did not think this was a good time to commit. Judge Self agreed with Commissioner Hoadland. Discussion followed on the effects of tax rates on business versus families. Commissioner Jaynes recommended the court vote on the homestead exemption first and look into the tax rate and capital improvements when getting deeper into the budget. Commissioner Jaynes moved to approve a 5% homestead exemption, Commissioner Cole seconded and the motion passed with 3-2 vote of the Court. Judge Self and Commissioner Hoagland voted no. (Time 2:21:47 p.m.)

Item No. 7 Al-28430 Consideration, discussion and any action regarding the Tax Abatement Agreement with Ensemble Studios/Microsoft and The Shops at Legacy (North) LLC, Reinvestment Zone No. 113, City of Plano. Judge Self commended Monika Arris, Budget, for her recommendation to the Court based on County policy. Commissioner Jaynes stated he would vote against the item because of Budget's recommendation that the abatement is against County policy. Commissioner Hoagland

moved to approve, Commissioner Cole seconded and the motion passed with a 4-1 vote of the Court. Commissioner Jaynes voted no. (Time 2:25:58 p.m.)

Item No. 8 Al-28404 Update, discussion and any action regarding the solid waste municipal solid waste facility site study, Public Works. Jon Kleinheksel, Public Works, addressed the Court stating R.W. Beck, who performed the study, was unable to appear. Mr. Kleinheksel presented the study. Mr. Kleinheksel requested that the Court create an ordinance which will allow the County to decide where the next landfill will be built in Collin County. Mr. Kleinheksel pointed out the only difference in the updated presentation was it included the outer Loop. He requested the Court move forward with approving an ordinance. Commissioner Jaynes stated he did not want the landfill in Collin County and he wanted the option of telling a builder no on where they could build. Commissioner Cole made a motion to direct Mr. Kleinheksel to bring back an ordinance for review by the Court. Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court (Time 2:32:47 p.m.)

COURT ORDER NO. 2008-460-06-23

Item No. 9 Al-28459 Update, discussion and any action regarding the Phase IV of the Solid Waste Management Plan, Public Works. Bill Hindman, Chiang, Patel and Yerby, Inc. addressed the Court with an update to Phase IV. This phase was preparing a document to seek proposals for someone to contract to collect waste outside the jurisdiction of the various cities. Mr. Hindman continued saying this proposal is to update the data and Phase IV, then come back to Court to determine whether or not to proceed. Mr. Kleinheksel said of the estimated 320 illegal dumpsites half are in the ETJ. Commissioner Jaynes moved to approve Phase IV, Commissioner Cole seconded and the motion passed with a 5-0 vote of the Court. (Time 2:39:02 p.m.)

Item No. 10 Al-28468 Consideration, discussion and any action regarding written notice received from IESI for the implementation of hauling charges to all recycling center locations, effective July 1, 2008 (not budgeted), Public Works. Jon Kleinheksel, Public Works, requested approval of a contract with IESI to remove trash from recycling centers stating 50% of the County's recycling centers have become illegal dumpsites. With this contract IESI will come out and remove the trash from the centers. Commissioner Jaynes moved to approve, Commissioner Hatchell seconded, and the motion passed with a vote of 5-0 of the Court. (Time 2:41:14 p.m.)

<u>Item No. 11</u> Al-28467 Consideration, discussion and any action regarding an additional trash day once a month and further authorize the payment of overtime in lieu of comp time due to the difficulty in staffing the trash day events, Public Works. Jon

Kleinheksel, Public Works, stated that this "Beautification Day" program has grown to 700 vehicles per event. It has become increasingly more difficult to staff the events because all that can be offered to employees is comp time. Judge Self asked what the cost would be. Cynthia Jacobson, Human Resources, stated if held once a month the cost would be \$20,000 annually, if held twice a month the cost would be \$40,000. Commissioner Cole commented that if we do not do something about the trash problem now, it will not go away. It will grow to a point that it will cost more money in damages than the cost of paying the overtime. Commissioner Jaynes moved to approve, Commissioner Cole seconded, and the motion passed with a vote of 5-0 of the Court. (Time 2:47:07 p.m.)

<u>Item No. 12</u> Al-28475 Consideration, discussion and any action regarding Personnel Appointments, Human Resources. Cynthia Jacobson, Human Resources, addressed the Court and stated all appointments are within standards. Commissioner Hatchell moved to approve, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time 2:48:26 p.m.)

<u>Item No. 13</u> Al-28476 Consideration, discussion and any action regarding Personnel Changes, Human Resources. Cynthia Jacobson, Human Resources, stated all changes are within standards. Commissioner Hatchell moved to approve, Commissioner Cole seconded, and the motion passed with a 5-0 vote of the Court (Time 2:48:47 p.m.)

COURT ORDER NO. 2008-465-06-23

AI-28469 Consideration, discussion and any action regarding the list of all Collin County Take Home Vehicles (Marked and Unmarked), Public Works. Jon Kleinheksel, Public Works, provided the Court with a brief description of the needs of each department. Judge Self asked Human Resources to provide a benefit amount that could be treated as compensation. Cynthia Jacobson, Human Resources, stated that IRS rules indicate if the vehicle is used for business purposes there is no taxation. Commissioner Cole commented that take home vehicles are not a benefit because that person would be on call 24 hours a day. Commissioner Hoagland asked if the plates are exempt. Mr. Kleinheksel said not all of them. Exempt is a law enforcement distinction and does not hold any monetary meaning. Unmarked cars are exempt, marked are non-exempt. Commissioner Hoagland said all County vehicles should be marked with the County logo and if the plates are non-exempt they should be identified as government plates. Sheriff Box addressed the Court and stated that Mental Health cars have to be unmarked by law and unmarked cars are not allowed for personal use whatsoever. The Sheriff also said his office is also looking at ways to cut gas costs and possibly eliminating some of the take home vehicles altogether. Constable Bob Bell Commissioners Court Minutes June 23, 2008 Page 11 of 12

addressed the Court and requested that if the Commissioners voted to mark all County vehicles, then he wanted his vehicles marked with the Constable's logo. Commissioner Hoagland made a motion to mark all County vehicles with the County logo and identify plates as government. The motion died for lack of a second. (Time 3:03:21 p.m.)

NO ACTION TAKEN

Item No. 15 Consideration, discussion and any action regarding 2007 RTR funding, Commissioners Court Commissioner Jaynes stated the Outer Loop is still not in the RTR, which is something the County should be looking at. The big thing is to get money back from Austin before the legislature meets. Commissioner Jaynes continued saying, Michael Morris, Director of Transportation, RTC is meeting with the Legislative Budget Board to try to do that and monthly meetings are set up with Mr. Morris. Commissioner Jaynes stated he and Judge Self will be attending and would be willing to alternate with the other Commissioners. There will be monthly meetings with TxDOT as well. Judge Self commented that he is meeting monthly with the Transportation Director of COG, the District Engineer from TxDOT and Commissioner Jaynes Collin County's RTC representative. (Time 3:04:07 p.m.)

COURT ORDER NO. 2008-411-06-23

Item No. 16 Possible future agenda items by Commissioners Court without discussion. Commissioner Jaynes stated the Court will have an RFP on the July 8, 2008 agenda. Plano, Allen, Fairview, Melissa, Anna and McKinney will also have the same RFP, which is to request a proposal on how to expedite rail service. Both RTC and COG said they would pay for this study. Commissioner Jaynes further stated the purpose of the study is to look at mass transit including buses. With the upcoming construction at Highways 75 and 380, one of the worst intersections in Collin County, Commissioner Jaynes would like to have TxDOT come to Court and discuss possibly building a tunnel under Highway 380 similar to the one at Spring Valley. (Time 3:11:17 p.m.)

The July 15, 2008, workshop was cancelled due to lack of quorum.

Monika Arris, Budget, re-addressed the Court to ensure everyone was aware that per the tax code the minimum is \$5,000 for the homestead exemption, so houses valued at less than \$100,000 would get the \$5,000 exemption instead of 5% of the value of their home. (Time 3:11:17 p.m.)
