David M. Smith, Plano, Texas, stated as election administrator for the Democratic Party he was in favor of the purchase of an additional 410 voting machines for the November 4, 2008, election.

Dan Dodd, McKinney, Texas, Democratic Party Chairman, came before the Court in support of the purchase of an additional 410 voting machines for the November 4, 2008, election due to an anticipated record number of voters in Collin County.

Victor Manuel, McKinney, Texas, stated he was approached by his constituents with concerns about the number of voting machines and number of paper ballots available for the November 4, 2008, election. ## **GENERAL DISCUSSION**

Consideration, discussion and any action regarding the Item No. 5 AI-28534 approval of an additional 410 voting machines in preparation for the November 4. 2008, General Election and budget amendment for same, Elections. Rowe, Elections, stated voting machines were last purchased in 2003. Ms. Rowe continued, stating due to anticipated growth and voter turn out additional voting machines are necessary, as well as computers for voter registration validation. Ms. Rowe would also like to have additional spare units. Judge Self asked about funding. Ms. Rowe said funding comes from the Equipment Replacement Fund and from rental fees to local jurisdictions. Ms. Rowe added that early voting machines must be held separately; they cannot be used again. Commissioner Jaynes stated the bottleneck begins with getting people registered. Commissioner Hoagland asked about barcode readers. Ms. Rowe stated they are available, but they require printers, computers and storage cabinets. Commissioner Hoagland requested facts and figures for barcode readers. Commissioner Jaynes moved to approve, Commissioner Cole seconded, and the motion passed with a 5-0 vote of the Court. (Time: 2:07:08 p.m.)

#### **COURT ORDER NO. 2008-501-07-08**

Item No. 6 Al-28520 Discussion regarding the acceptance of a Mobile Medical Unit, supporting equipment, supplies and 2 generators on a permanent loan basis from the Department of State Health Services (Health Resources and Services Administration grant funds) at no cost to Collin County, Homeland Security. Kelley Stone, Homeland Security, came before the Court with a Power Point presentation entitled "Mobile Medical Surge Unit". Mr. Stone stated Homeland Security was approached by the North Central Texas Trauma Regional Advisory Committee (NCTTRAC) about receiving two 20 bed mobile surge units. Homeland Security's obligation would be to store these units, with NCTTRAC maintaining all medical supplies and equipment in another site. This equipment is worth over \$500,000; however, the cost to Collin County would be for fuel and use of a vehicle to pull the equipment. Mr. Stone said he spoke with Jon Kleinheksel, Public Works, about a temporary storage facility as well as having a vehicle available. Commissioner Jaynes stated this would be like a mobile army surgical hospital. Commissioner Cole commended Mr. Stone for bringing this to the citizens of Collin County. Commissioner Ward asked if this unit could be used for other things, such as blood drives. Mr. Stone said yes, but there is a limit to the number of times the unit can

be put up and taken down. Commissioner Cole moved to approve, Commissioner Jaynes seconded, and the motion passed with a 5-0 vote of the Court. (Time: 2:15:11 p.m.)

Item No. 7 Al-28511 Consideration, discussion and any action regarding the Tax Abatement Agreement with Diodes Incorporated, Reinvestment Zone No. 114, City of Plano. Judge Self stated this request came from the City of Plano, but does not meet the County's policy on tax abatement. Commissioner Jaynes stated Plano should have had a representative present in Court. (Time: 2:17:37 p.m.)

Consideration, discussion and any action regarding the Item No. 8 AI-28504 approval to move forward with the IT Enterprise Solution for the upgrade of Peoplesoft, CIJS Odyssey, VMAre, MS Exchange hardware and software environments, Information Technology. Caren Skipworth. Technology, came before the Court with an update for information purposes on the Architecture Enterprise Solution Plan in both hardware and software areas. Ms. Skipworth stated she wanted to propose an Enterprise Solution so that whatever equipment is brought into Collin County will be standard; it will grow with the County, the architecture can be added to, and a standard process can be put into place to control costs and efficiency. Ms. Skipworth directed the Court's attention to a Power Point showing new technology and addressed each slide. Skipworth concluded by saying she would like to send this scope of work out to get back better pricing and then bring that back to the Court for further discussion. Judge Self asked Ms. Skipworth to let the Court know what the impact on the user will be and what the cost benefit ratio will be. Judge Self felt this would help productivity. (Time: 2:26:52 p.m.)

#### NO ACTION TAKEN

Item No. 9 AI-28489 Consideration, discussion and any action regarding the issuance of the Crawford Education Facilities Corporation Adjustable Rate Demand Revenue Bonds, Series 2008 for the McKinney Christian Academy Project and adoption of a resolution for same, Administrative Services. Bill Bilyeu. Administrative Services, stated this is before the Court as an FYI notifying the Court of debt being issued elsewhere, but before the money can be expended in Collin County, the Court has to be notified. Mr. Bilyeu stated this bond was being used for McKinney Christian Academy, where a public hearing was held this No negative or positive comments were received. Commissioner Hoagland asked if this was for tax free bond status. Cliff Blount, Naman Howell Smith & Lee, stated this is a federal tax requirement under the Internal Revenue code for the bonds that are issued to be tax exempt. Commissioner Hoagland felt this was a law that does not make sense. Judge Self stated this is transparent government. Mr. Blount stated Crawford Education is a corporation established under state statute that gives that entity the authority to issue bonds anywhere in the state. Commissioner Hoagland stated the government wants County officials to approve this, which removes them from the process. Discussion followed

between Mr. Bilyeu, Mr. Blount and the Court. Commissioner Jaynes moved to approve, Commissioner Hoagland seconded, and the motion passed with a 5-0 vote of the Court. (Time: 2:36:19 p.m.)

### **COURT ORDER NO. 2008-503-07-08**

Al-28448 Consideration, discussion and any action regarding the Item No. 10 inclusion of an Employee only Fitness Center in the Courthouse Addition Bond Program (not budgeted), Construction & Projects. Commissioner Jaynes stated he put this item on the agenda due to numerous requests from employees. fitness center would be set up in unused space using donated equipment. Bill Burke, Building Projects Manager, approached the Court and stated he had one clarification to the memo which outlined several thousand square feet as an outside limit. Commissioner Hoagland asked Cynthia Jacobson, Human Resources, if the County had a reimbursement plan for employees who want to work out. Ms. Jacobson stated it has been discussed, but there is currently no such plan. Tracking becomes an issue. Commissioner Cole stated this would involve a minimal investment. Judge Self stated he asked a number of people for input and received responses from 60 people who did not support the fitness center. Commissioner Ward stated just because you build it does not mean they will come. She suggested building relationships with places that have family friendly activities. Commissioner Jaynes asked Ms. Jacobson for an overview on what has been done in the past, what the County currently offers, and what the County can offer. Commissioner Ward suggested challenging a comparably sized county to see who has healthier employees. (Time: 2:47:54 p.m.)

# **NO ACTION TAKEN**

Judge Self called a ten-minute recess. The Court recessed at 2:47 p.m. and reconvened at 2:59 p.m., with all members present and participating.

Item No. 11 Al-28406 Consideration, discussion and any action regarding the Financial Transparency Project, Commissioners Court. Judge Self stated he requested this informational briefing be on the Court due to the increasing number of government entities putting their checkbooks online in Texas. Judge Self would like this to be the next step for Collin County to give transparency to citizens. Caren Skipworth, Information Technology, outlined a Power Point presentation highlighting Arlington ISD. Judge Self stated citizens would be able to go online and see how their tax dollars were being spent. (Time: 3:03:45 p.m.)

### NO ACTION TAKEN

Item No. 12 Al-28478 Update, discussion and any action regarding a Tunnel Intersection at US 380 & 75 by the Texas Department of Transportation (TxDOT), Commissioners Court. Ron Johnston, Collin County Area Engineer, TxDOT, stated that TxDOT is looking into future plans for getting traffic through the US 380 and 75 intersection. The best solution would be a tunnel because a bridge over 75 would not be feasible. Mr. Johnston cited a concept and model which could be seen at 75 and Spring Valley in Richardson. Mr. Johnston presented a Power Point slide show and talked about the project and the process. Commissioner

Jaynes asked Mr. Johnston if he visited with the City of McKinney. Mr. Johnston replied that he had and he will be making a similar presentation to the McKinney City Council. Mr. Johnson stated approximately 100,000 cars go through that intersection daily. Commissioner Jaynes said he would like Mr. Johnston to proceed with the study and meet with the City of McKinney. Mr. Johnston stated either the City of McKinney or Collin County would need to do a feasibility study. Commissioner Jaynes stated he would like to attend a work session or council meeting with TxDOT and the City of McKinney. Commissioner Hoagland asked Bill Bilyeu, Administrative Services, whether there was money in the budget. Mr. Bilyeu replied bond money could be used. Judge Self thanked Mr. Johnston for a great presentation and asked him to let the Court know when he meets with the City. (Time: 3:23:56 p.m.)

### **NO ACTION TAKEN**

<u>Item No. 13</u> Consideration, discussion and any action to waive physical requirements before hiring a Voter Registration Coordinator, Elections:

Al-28533 Hire a Voter Registration Coordinator contingent on the candidate passing the new hire physical. Sharon Rowe, Elections, requested that the Court approve the hiring of a Voter Registration Coordinator on the contingency that she passes the physical exam before beginning work in Collin County. Since the candidate was coming from the Office of Secretary of State in Washington, she had to wait until she arrived in Collin County to receive her physical. Ms. Rowe stated a starting salary needed to be discussed and agreed upon as well. Commissioner Cole wanted to know why she could not take her physical in Washington. Cynthia Jacobson, Human Resources, stated it was a coordination effort. Commissioner Cole moved to allow Ms. Rowe to hire the person she wanted and Commissioner Ward seconded. Before the final vote, discussion continued, with Ms. Rowe requesting that the new hire's information be presented today. Discussion followed regarding salaries in comparable counties. The motion passed with a 5-0 vote of the Court. (Time: 3:32:36 p.m.)

The average salary for County law enforcement officers is \$50,000, with approximately 60% of law enforcement officers being within 10% of the maximum pay range. Ms. Jacobson noted deputy sheriffs have a 2% turnover rate. Discussion continued with Ms. Jacobson listing each position's salary range. Commissioner Javnes asked about city/county comparisons. Ms. Jacobson did not have a defined comparison. Judge Self noted that Collin County is a leader in pay ranges when compared with comparable counties. Terry Box, Sheriff, stated his office loses law enforcement officers to many of the cities in Collin County due to higher salary opportunities. Judge Self asked how the County can balance an 8.5% pay increase for law enforcement against tax revenues. Discussion followed on positions, salaries and percentage increases, as well as pay for performance. Commissioner Ward stated a decision does not need to be made today as this is the first time this information has been presented to the Court. Commissioner Jaynes agreed with Commissioner Ward. Commissioner Hoagland asked for a presentation on the basis of Pay for Performance. Commissioner Ward asked for a real life scenario of how this would effect employees. Judge Self thanked Ms. Jacobson for her presentation. (Time: 4:21:52 p.m.)
