Mayor Jim Lewis, City of Celina, and Jason Gray, Celina City Manager, came before the Court with an update on the progress of the Tollway through Celina. Present in the courtroom were two landowners who were committed to providing land for the right-of-way. Mr. Gray stated committed right-of-way documents would be signed before the end of the year. Judge Self asked if this included up to FM 455 or above. Mr. Gray stated this section of the project extended just north of FM 455. Grayson County is verbally committed. Commissioner Jaynes asked if the Court could help. Mr. Gray felt it was better to have one-on-one negotiations with homeowners at this time. (Time: 3:16:45 p.m.)

AI-28634 Consideration, discussion and any action regarding HOV Item No. 6 Lanes on US 75, Commissioners Court. Ruben Delgado, Engineering, introduced Koorosh Olyai, Assistance Vice President, NTTA Mobility Program, to present an update regarding the HOV lanes on US 75 between Richardson and Plano pursuant to a request by Commissioner Hoagland. Mr. Olyai presented a Power Point outlining the progress of the HOV lanes on US 75, stating they service 165,000 passengers during weekdays and usage has increased by 27% in the past five months. Commissioner Hoagland stated he felt the project has been a failure: 80-90% of the vehicles contained one passenger and access and egress is Commissioner Jaynes felt the HOV lane would be "disastrous" in Mr. Olyai acknowledged there are opportunities for improvement. McKinnev. Currently there are 8,000 pylons along a fourteen-mile stretch of highway; that will be reduced to 4,000 pylons. Commissioner Hoagland would like to see the pylons removed completely. Both Commissioner Hoagland and Commissioner Jaynes felt that the pylons were a safety hazard. Mr. Delgado stated the original concept was for a zipper lane, but the cities did not support that. NorthStar has many services available to the residents of Collin County. Commissioner Jaynes stated Collin County is not pulling out of NorthStar; rather, they are trying to better utilize their services. Commissioner Ward applauded the citizens and volunteers who came to support

NorthStar. Judge Self stated Collin County's population increases 5% annually, yet enrollment in NorthStar remains the same or decreases.

Pastor Rock Carpenter, McKinney, Texas, addressed the Court in support of NorthStar, as a pastor, licensed therapist and chaplain for McKinney Police Department. He requested more services and more income to meet the needs of the citizens.

Sherry Cusumano, Plano, Texas, is a psychiatric nurse, registered nurse, and a licensed chemical dependency counselor working at Green Oaks Hospital. She is also the president of NAMI (National Alliance for Mental Illness). She came forward and spoke on behalf of the stakeholders in the Collin County area. Ms. Cusumano stated they were "thrilled" to learn that the Court wanted to increase the number of services and money spent on public mental health. She offered to provide the Court with a list of names and contact information for the public health system.

Tracy Westhoff, McKinney, Texas, licensed master social worker, Assistant Executive Director, Samaritan Inn, came before the Court as a representative of Collin County's homeless shelter. Ms. Westhoff stated approximately 40% of the residents at the Samaritan Inn receive services from NorthStar. She felt that intervention and options would help provide preventative measures.

Sharon DeBlanc, Allen, Texas, NorthStar, NAMI board member, handed out posters to the Court advertising the services of NorthStar. Additionally, business cards were being printed which would be given to police departments, the sheriff's department, fire stations, and first responders listing their services and contact numbers. Regional Mobility Authority, presented the Court with an overview of the goals and processes used when the RMA was created in Travis and Williamson Counties. Mr. Heiligenstein showed the Court a Power Point presentation outlining, among other things, the powers and responsibilities of RMA and mobility authority legislation. The presentation and overview continued, highlighting the positives and negatives of creating an RMA. Judge Self asked about private activity bonds. Mr. Heiligenstein replied they are not currently using private activity bonds, nor are they being contemplated for their next project; tax exempt is the preferred way to Commissioner Jaynes questioned whether an RMA is an option. proceed. Discussion followed between Mr. Heiligenstein and Commissioner Jaynes. There was a discussion of financing. Upon inquiry by Judge Self, Mr. Heiligenstein stated

he had a good relationship with their MPO; they were dynamic and driven to get projects completed. Rob Collins, Attorney, Vinson & Elkins, Dallas, Texas, approached the Court and provided them with additional information and documentation regarding RMA's, continuing the Power Point presentation. Mr. Collins introduced Glenn Opel, Attorney, Vinson & Elkins, Austin, Texas, as the next speaker. Mr. Opel works closely with CTRMA and was available to answer detailed questions about financing issues faced by the RMA's. Mr. Heiligenstein again approached the Court and concluded his presentation. Judge Self thanked the speakers for their briefings. (Time: 6:06:53 p.m.)
