This year Collin County is proposing a property tax rate of \$0.2425, that rate would raise \$174,324, 065, which is \$7,439,490 more than the taxes imposed last year. By contrast, for a \$100,000 home with the newly adopted 5% homestead exemption, this additional tax revenue would decrease Two public hearings have been scheduled to consider the taxes by \$14.63. increase: the first public hearing will held on August 26th at 9:00 a.m. in the Commissioners Courtroom, located in the Collin County Government Center. 210 S. Ms. Arris continued with her Power Point, stating according to the U.S. Census Bureau, Collin County's population has increased by 4.9% to 730,690. Tax rate growth: as of July 25, 2008, 4.6%, including homestead exemption. Not including homestead exemption, increase would have been 7.5%. Average home in Collin County is valued at \$222,612. Tax rate at \$0.2425, representing no tax increase for the 16th year in a row, has the average homeowner paying \$539.83, a savings of \$25.66 over last year. The total authorized positions are 1,784, with three positions being eliminated by the first of the year. General fund, \$150,000,000, an increase of \$4,200,000. Operating budget: \$172,800,000, an increase of 4.2% over last year. Total Combined Budget: \$268,200,000. Ms. Arris then listed reasons for increases in budget.

Judge Self asked Bill Bilyeu, Administrative Services, for a briefing on the wellness Mr. Bilvey replied he received a proposal to do a wellness study. Estimated cost is \$1,200,000, but a bid would have to go out to clinics that offered the same services. Commissioner Hoagland wanted feedback through HPPA as to the success of the program. Mr. Bilyeu stated that would have to be voluntarily provided by the employee. Commissioner Cole supported the program, stating the results would save lives. Commissioner Jaynes wanted to hear more about the program. Dr. M.
