GENERAL DISCUSSION

Item No. 5 Al-28744 Public Hearing - Consideration, discussion and any action regarding the placement of Regulatory Signs on various County Roads, Public Works. Jon Kleinheksel, Public Works, addressed the Court with requests for speed limit signs in areas of new construction with the exception of one school zone and two residential areas. Judge Self asked if there was any public comment

on this item. No one came forward. Commissioner Hoagland commented on concerns that were raised due to the speed limit at Harper Elementary School in Princeton. Mr. Kleinheksel stated that to put up a speed limit sign takes approximately 30 days due to the required process. Mr. Kleinheksel continued by saying that if the concern raised by Commissioner Hoagland was regarding the school in Princeton, he could have a sign up the next day if approved by the Court. Commissioner Jaynes moved to approve, Commissioner Ward seconded and the motion passed with a 5-0 vote of the Court. (Time: 1:56:46 p.m.)

Item No. 6 AI-28870 Discussion and any action regarding the creation of a Collin County's Citizen Academy, Commissioners Court. Commissioner Ward made a proposal to Court members regarding creating a Citizen's academy which would include department heads meeting with the County's community leaders to highlight the duties and responsibilities of the various departments. This would give the County's citizens a better idea of how the County operates and what services each department provides and highlight the good these departments are doing for the County. Commissioner Ward suggested the academy meet one Saturday each quarter and that the County Judge or a Commissioner should be present at each meeting. Commissioner Ward also proposed that the academy be formed and start meeting beginning the next calendar year. commented that this would be excellent next step in the County's open government initiatives to let the citizens know what the County does. The proposal was discussed by the Court. Commissioner Ward moved to approve with a 10 person planning board, Commissioner Hoagland seconded and the motion passed with a 5-0 vote of the Court. (Time 3:58:50 p.m.)

Item No. 7 Al-28871 Discussion and any action regarding Commissioners Court Governance and Operations, Commissioners Court. Commissioner Hoagland gave comments regarding the responsibilities and authority of the members of Commissioners' Court. Commissioner Hoagland stated that should someone have a need to give a department head a direction, that person should go to the Director of Administrative Services, Bill Bilyeu, as the direct report. Discussion among Court members ensued. Judge Self asked if there was any other discussion. No additional discussion followed. (Time 4:16:23 p.m.)

NO ACTION TAKEN

Item No. 8 Al-28796 Consideration, discussion and any action regarding the Outer Loop section from FM 6 to US 380, Commissioners Court. Bill Bilyeu, Director of Administrative Services, addressed the Court to explain what this item entailed. Ruben Delgado, Engineering, addressed the Court stating an item that recently came to Engineering's attention was a development in the City of Josephine that was encroaching on the County's preferred alignment. Mr. Delgado told the Court that it was urgent that the County correspond with the City of Josephine regarding right-of-way needed to move forward with the Outer Loop project. Discussion followed. Commissioner Jaynes made a motion to start the

field note process and bring the rest of the alignment back to the next Court. Mr. Delgado told the Court they needed to choose an Engineering Firm for the project. Commissioner Hoagland stated the firm chosen was CH2M Hill. Frank Ybarbo, Purchasing, addressed the Court stating this part of the project was not included in the Request For Quote (RFQ). Judge Self asked if the County could expand the RFQ. Mr. Ybarbo replied if the Court thought they were the most qualified, then, yes, they can expand the RFQ to include this section of the project. After a firm was chosen, then the County could start the negotiation process. Commissioner Jaynes moved to approve CH2M Hill, Commissioner Ward seconded and the motion passed with a 5-0 vote of the Court. Judge Self asked if any further action was needed. Mr. Delgado stated there was none. (Time: 4:22:48 p.m.)

<u>Item No. 9</u> <u>AI-28858</u> Consideration, discussion and any action regarding approval of the legal pay scale, Human Resources. John Roach, District Attorney, addressed the Court regarding an increase for Prosecutors' salaries. Judge Roach gave Court members handouts which included proposed increases and the departmental Organizational Chart. After a short commentary he requested that the Court allow Cynthia Jacobson, Human Resources, to give her presentation first and then his would follow. The Court agreed and Mr. Roach gave the floor to Ms. Jacobson. (Time: 1:58:50 p.m.)

Cynthia Jacobson, Human Resources, addressed the Court with a Power Point presentation on legal salaries, which she stated was a standard presentation Human Resources provided annually. Ms. Jacobson stated she understood there were concerns about the salaries in the District Attorney's Office and that her department had tried to address those concerns. The presentation included turnover, salary comparison charts with comparable counties, and a survey of defense attorneys' salaries. Discussion with Court members was conducted throughout the presentation. Ms. Jacobson submitted two recommendations on the legal salary increases to the Court for consideration. (Time: 2:33:47 p.m.)

Judge Roach re-approached the Court with brief comments concerning Ms. Jacobson's presentation. Judge Roach indicated there was some information in the presentation that his department disputes. He also told the Court of the high level of training he provides to the Prosecutors in his office. After making his comments to the Court, Judge Roach turned the floor over to Cynthia Walker, District Attorney's Office, to give a presentation for their office. (Time: 2:37:58 p.m.)

Cynthia Walker, District Attorney's Office, addressed the Court requesting approval for an increase in Prosecutors' salaries. Ms. Walker used Ms. Jacobson's presentation to show the differences in her findings compared to those of Human Resources. Discussion with Court members was conducted throughout the presentation. A handout containing legal salaries in Tarrant County was given to Court members. (Time: 2:54:20 p.m.)

At the request of Judge Self, Ms. Jacobson re-approached the Court for further discussion on the increases. Judge Cindy Wheless, 417th District Court, addressed the Court to comment on the need for qualified Prosecutors and the need to pay them a competitive salary. After consideration of the recommendations from Human Resources, Commissioner Ward asked if a \$2,500 bonus would make a new Misdemeanor Prosecutor stay. Daniel Lewis, District Attorney's Office, responded to the question. Mr. Lewis commented that the bonus would not be useful because Misdemeanor Prosecutors typically move up in less than one year. After extensive discussion between all parties and the Court, Commissioner Ward made a motion to approve a 7% increase for legal salaries and give Misdemeanor Prosecutors a \$2,500 bonus if they stayed for one year, Commissioner Jaynes seconded and the motion passed with a 4-1 vote of the Court. Commissioner Cole voted no. (Time: 3:54:46 p.m.)

A Temporary Pool has been created specifically for the Sheriff's Office to assist with video visitation at the jail. Commissioner Hoagland made a motion to approve, Commissioner Cole seconded and the motion passed with a 5-0 vote of the Court. (Time: 4:23:21 p.m.)

passed with a 4-1 vote of the Court. Commissioner Hoagland voted no. (Time: 4:32:10 p.m.)
