Item No. 5 Al-29159 Public Hearing - Consideration, discussion and any action regarding the placement of Regulatory Signs on various County Roads, Public Works. Jon Kleinheksel, Public Works, came forward and stated the request for regulatory signs was for approximately 70 miles of new road construction. Judge Self asked if any member of the public wanted to comment on the regulatory signs. There were none and Judge Self closed the public hearing. Commissioner Jaynes made a motion to approve, Commissioner Hoagland seconded, and the motion passed with a 4-0 vote of the Court. (Time: 1:59:03 p.m.)

Commissioner Hoagland made a motion to establish an account, Commissioner Cole seconded, and the motion passed with a 4-0 vote of the Court. (Time: 2:07:19 p.m.)

Commissioner Jaynes liked the idea. Terry Box, Sheriff, supported the program. Commissioner Hoagland made a motion to approve, Commissioner Jaynes seconded, and the motion passed with a 4-0 vote of the Court. (Time: 2:11:33 p.m.)

Commissioner Hoagland made a motion to approve based on HR's recommendation, Commissioner Cole seconded, and the motion passed with a 4-0 vote of the Court. (Time: 2:13 p.m.)

Judge Self felt the Court was familiar with the issues due to prior discussions and made a motion to address this matter today. Judge John Roach, Jr., come forward

and again presented an argument for the need for three additional district courts. Case study estimates the average is one district court per 55,000 residents; Collin County has one district court for every 95,000 residents. Judge Self stated the OCA agrees that Collin County is ahead, not behind, in adding courts. Discussion continued between Judge Roach and the Court, which included an update on Odyssey. Richard Abernathy, Attorney, spoke about the need for additional courts from the civil lawsuit perspective, noting, per statute, criminal cases are heard before civil cases, which can cause hardship for his clients. Sharon Easley. Attorney, addressed the Court next, stating in her experience, Collin County judges are the most efficient. As a family law attorney, Ms. Easley felt three courts were needed to meet the growing demands of the County. Judge Dry returned to address the Court, stating the biggest problem the district courts are facing right now is Odyssey. Additionally, according to a study, Collin County courts are the second busiest courts in Texas. Judge Self dislikes the use of videoconferencing with defendants; stating he prefers to speak directly to the defendants and their families. Finally, Judge Dry supported the need for three additional courts, failing to "see the downside of doing too many courts quickly". Commissioner Cole requested that this item be continued until Judge Oldner could appear. Judge Self withdrew his motion and stated the issue would be held. (Time: 3:15:01 p.m.)

Commissioner Jaynes presented an update on RTR funding, stating he voted against the creation of a transportation district. Commissioner Jaynes also notified the Court that Rider Scott would be present to speak at the next Court. (Time: 3:16:51 p.m.)
