<u>Item No. 1</u> Commissioner Cole convened the <u>Collin County Health Care</u> <u>Foundation</u> meeting to order at 1:30 p.m.

<u>Item No. 2</u> Commissioner Cole asked if any member of the Board or any member of the audience would like to have an item pulled off the consent agenda for individual consideration. Trustee Hoagland pulled items 2c, d and f. Trustee Hatchell motioned to approve the remainder of the consent agenda, Trustee Jaynes seconded, and the motion passed with a 4-0 vote of the Board. President to finalize and execute same (budgeted NTE \$400,000), Health Care. Trustee Hoagland stated he was voting against this item because the County is doing more than required by law. Candy Blair, County Health Care Administrator, stated this is for children and adults at the poverty level, they pay the co-pay, County pays the difference at a contracted rate. Ms. Blair continued, \$400,000 was budgeted for this item last year, \$136,000 was paid out as a result of 1,189 visits to PrimaCare. Trustee Cole stated that was a good use of funds. Trustee Jaynes motioned to approve, Trustee Hatchell seconded, and the motion passed with a 3-1 vote of the Board. Trustee Hoagland voted no. (Time: 1:35:59 p.m.)
