Trustee Cole told the Board of the necessity for this type of program in Collin County, and how the program not only provides children with much needed healthcare, but also teaches mothers about pre-natal care and how to care for their children after birth. Trustee Jaynes moved to approve, Trustee Cole seconded and the motion passed with a 4-1 vote of the Board. Trustee Hoagland voted no stating that this issue should be brought to the attention of state and federal government and said he would draft a letter and present it to the Board for consideration.
