GENERAL DISCUSSION

5. Al-29540 Update on Justice Courts, Justice of the Peace, Precinct 1.

Judge Raleeh gave a powerpoint presentation on the number and types of cases processed by the five Justice of the Peace Courts. Judge Raleeh stated that it was decided by the JP Judges to give an annual update at the beginning of each fiscal year, but since there are new Commissioners on the Court they decided to wait until the beginning of the new year so they could see the presentation as well.

Judge Raleeh continued by saying the courts are seeking out new technology to increase the collection rate on fines and fees. They are also working on expanding a program to include revoke/deny multiple licenses for those who have outstanding fines and fees until those monies are paid. Judge Raleeh ended with a video on Collin County which will be shown in conferences across the nation. Judge Self commended Judge Raleeh for becoming the second entity to post his Court's checkbook online thus expanding the County's latest policy on transparency in government for the citizens of Collin County.

6. Al-29450 Presentation, discussion and any action regarding Illegal Dumping and Environmental Enforcement presented by Mr. James Park of McLennan County, Public Works.

Jon Kleinheksel, Public Works introduced James Park from McLennan County who gave a presention to the Court on the program his county developed to better handle the increasing problem of illegal dumping.

Mr. Park said he averaged 60-70 cases per month where some type of action was taken. 235 citations and 84 arrests were made by Mr. Park from November 1998 through August 2007. McLennan County used public service announcements, which were paid for by grants, and brochures to inform the public of the consequences of illegal dumping and to educate the community. Mr. Park said each Commissioner has a Deputy that manages his/her precinct's illegal dumping. They are using prisoner utilization to assist with trash pick up.

Commissioner Jaynes requested the number of citations and arrests in Collin County from Fire Marshal Steve Diffibaugh for comparison to McLennan County's numbers.

Discussion with Mr. Park and court members including questions from the court regarding Mclennan County's program. Judge Self and the Commissioners agreed that the County should proceed with investigating this program and pursuing a better, more cost effective program. Judge Self asked Mr. Park to continue coordinating with Mr. Klienheksel to improve processes in Collin County.

Ms. Skipworth also stated that the purchase orders referenced by Mr. Cozad in his memo were allocated to another project and requested that the County not use those funds until an ERP project had been established. Questions and comments generated discussion by the Court. Bill Bilyeu, Administrative Services addressed the Court to discuss taking action on perfromance based pay for a department who is not able to participate in the program because one of the staff is over the maximum range and the department is so small there is no competitive environment. Discussion followed. The Court asked Ms. Jacobson to obtain more information on the staff and their salaries and bring it back to the next Court.

Cynthia Jacobson, Human Resources addressed the Court with a request from an employee who asked that the County pay for the medical procedure Panniculectomy. Ms. Jacobson explained that this is a medical procedure to remove excess skin which is performed after someone loses a large amount of weight and is typically associated with Lapband weight loss. Marvin Wilson addressed the Court representing the Republican Men's Club. Mr. Wilson gave a powerpoint presentation on this elective surgery and listed some of the dangers associated with the procedure. After the presentation Mr. Wilson stated his associates, who are also taxpayers in Collin County, do not think this procedure should be covered or paid for by the County as it is an elective surgery. Commissioner Shaheen stated that he wanted to ask that this topic be placed on a future adenda item for the Court to review its policy on weight loss surgeries.

Judge Chris Oldner, 416th District Court addressed to request additional courts. Judge Oldner presented updated statistics to the Court stating the rating for clearing cases dropped from 95% to 87%. Discussion followed with questions from the court. Judge Oldner continued by saying the auxillary court does not assist is clearing cases.

Comments from Judge Self referencing an email discussing disposed cases as reported by the OCA. Judge Self stated the County increased capacity by 11% by adding the 429th court. Judge Self said in his opinion the County is dispensing justice and serving the citizens because of the new Court.

Discussion followed with Judge Self suggesting raising the cap on the County Court at Law Courts and have these Courts hear felony DUI instead of just

misdemeanor cases. Additional discussion followed. Judge Self stated the county disposes of 70% of its cases in six months or less. He also stated cases that go over one year is at 11%. Discussion continued regarding other options for addressing the issue of clearing cases in a more timely manner.
