<u>ITEM NO. 13</u> Al-29601 Consideration, discussion and any action regarding the lap band procedure, Human Resources. Since there were numerous speakers on this topic, Judge Self instructed them that they would each have three minutes to address the Court.

Dr. Nirmal Jay-Seelan, a lap band surgeon, came forward and stated he felt it would be unfair to exclude treatment for morbid obesity. Morbid obesity has genetic causes and is not just driven by psychological reasons.

Dr. Frank T. Feltz, a bariatric surgeon, came before the Court with facts about obesity, the disease, diagnosis and various causes. Dr. Feltz was in favor of the County continuing its coverage of lap band surgery. Health care costs for obese patients are at least four times that of non-obese patients.

Donna Gelvin, Blue Ridge, Texas, spoke next. Ms. Gelvin is a 30-year County employee who received lap band surgery in 2004. Ms. Gelvin shared "before and after" pictures with the Court, and stated she was on numerous medications for numerous conditions before the surgery. Shortly following the surgery she was able to discontinue all medications. Ms. Gelvin feels she is a more productive employee, with a better quality of life.

Jennifer Baker, McKinney, Texas, agreed that lifestyle changes are needed for overweight people; however, for many the only option is weight-loss surgery. Ms. Baker stated the decision to have this surgery is a lengthy one, requiring twelve months of counseling with health care providers. Ms. Baker also requested the Court continue its coverage of lap band procedures.

Marcia Simpson, McKinney, Texas, approached the Court. She, too, was a recipient of lap band surgery. Ms. Simpson stated she is currently diabetes free and takes no medications. She felt if she was addicted to heroin or some other drug instead of food, the County's benefits would cover rehabilitation.

Becky James, Bonham, Texas, stated the date of her lap band surgery is her new birthday. To date Ms. James has lost 314 pounds. Ms. James stated lap band surgery is a tool and the recipient must learn to work the tool in order for it to work for them. She is proud to be Collin County's "biggest loser".

Rosemary Gammon, Plano, Texas, came forward as a representative of American Institute of Gastric Banding, the largest lap band provider in the United States. Ms. Gammon stated lap band is quite different than gastric bypass. Ms. Gammon asked the Court to look at the cost of the surgery compared to savings from prescription medications, emergency room visits, doctors' visits, EKG's and Workers' Compensation.

Veronica Clark, Dallas, Texas, stated that at 22 years of age she did not have serious health conditions, but at 225 pounds, with a family history of diabetes, high blood pressure, and heart disease, eventually she would. Lap band surgery has enabled her to lose 65 pounds. Without insurance, Ms. Clark would not have been able to afford this "tool". She feels this procedure is important for younger people to help prevent serious illnesses in the future.

Cynthia Jacobson, Human Resources, came forward to present a Power Point of factual-based information to assist the Court in making their decision. Bariatric surgery covers more than just lap band surgery. Ms. Jacobson added weight management has been added to help prevent people from regaining weight following weight loss. Commissioner Hoagland had questions concerning lap band recipients who had gained weight back. Ms. Jacobson continued, stating prior to nutrition management the County was paying for 30 to 50 lap band procedures per year; currently those numbers have dropped to 15 to 25 procedures per year. The average cost of surgery is between \$15,000 and \$30,000. Questions and answers followed, with more explanation. In response to a question from Commissioner Hoagland, Dr. Jay-seelan stated in 1965 less than 10% of the population was morbidly obese; today that number is 30%. Commissioner Hoagland stated he did not feel obesity was a disease.

Commissioner Shaheen came forward and presented a Power Point presentation entitled "Leading Causes of Death in 1900". Commissioner Shaheen questioned taking money from taxpaying citizens in these tough economic times for this type of procedure. Commissioner Ward added "tough times call for tough financial decisions". Judge Self read an email from a citizen who is against using tax dollars for weight loss surgery. This citizen works in the private sector and is facing less benefits, no pension, less training, less vacation, and no salary increases. Commissioner Shaheen motioned to discontinue funding for lap band surgery. (Time: 2:34:14 p.m.)
