ITEM NO. 2 Public Comments.

Glen Renfro Allen, Texas, approached the Court to give comments on two different topics: Groundwater Conservation District and Myers Park. Mr. Renfro first addressed the Groundwater Conservation District as a representative of Hurricane Creek County Club, Anna, Texas. They were concerned about the impact on people being able to drill wells and how much usage would be available for homes, golf courses and municipalities.

Additionally, Mr. Renfro spoke in support of Myers Park, stating it was the best kept secret in the county.

Paul Furr, Prosper, Texas, gave comments regarding Myers Park, also stating the county should continue to support the Park for the FFA and 4-H members of the county as it gives members a place to show.

Norman Gidney, McKinney, Texas, also spoke in support of Myers Park. Mr. Gidney has been using the Youth Park since 1969. Thousands of citizens have benefited from using the park.

Terri Ricketts, Blue Ridge, Texas, came forward. Ms. Ricketts was president of the Chamber of Commerce in McKinney for ten years, and, as a result, learned a lot of the history of Myers Park. Ms. Ricketts also asked the Court to continue support of Meyers Park.

Phil Prosser, Celina, Texas, land owner, read a prepared speech regarding the county's staking of right-of-way for paving which destroyed several trees which were valuable to his land. He said the county also trespassed on his property and burned a brush pile which he had created for fire wood and mulch. After his statement Judge Self commented since this was not on the agenda, the Court could not discuss.

Glen Coleman commented on Myers Park, stating the county should continue support of the park. (Time: 9:48 a.m.)
