
**COURT ORDER NO. 2009-158-02-27**

Judge Self read the definition of outdoor burning into the record at the request of Commissioner Jaynes. Commissioner Jaynes asked if welders would be able to work. Judge Self replied welders could work, but they would be required to have a fire watch. (Time: 9:02:09 a.m.)


