Cook County has expressed an interest in joining in with Collin and Denton Counties in a multi-county groundwater conservation district. Discussion followed concerning the make-up of a Groundwater Conservation District Board. Philip Sanders, City Manager, City of Anna, expressed concern because the City of Anna has invested heavily in infrastructure to provide water to their citizens; they are 100% reliant on groundwater for its citizens. Anna has grown 600% since 2000. Ms. Homfeld added there are seven groundwater producers in Collin County, with Anna being the largest. Ms. Sanders stated Anna's primary concern is the representation on the governing body of the Board for the groundwater conservation district. Commissioner Gary Hollowell, Cooke County, stated the common goal was to represent the people and reduce costs. Judge Self recommended approving the tri-county GCD, with a Board consisting of three members from each county with a rotating chairman. Judge Self made that recommendation in the form of a motion.
