**Purpose:**  
 The University of Texas at Dallas and the Air Force Office of Scientific Research are interested in funding data sharing research, development, and test of specific technologies that are also key to the North Central Texas Fusion System users. As a result of this project, the North Central Texas Fusion System users will automatically receive new information that relates to their investigations or areas of analysis. The development and monitoring of the top ten threats to the County or the North Central Texas Region, for example, can be significantly more timely and thorough because of this automation. Additionally, the extremely time-consuming tasks of extracting linkages, map locations, and timelines embedded in the data will be automated. Note that these functions are already implemented in the Fusion System for database data and will be extended on this project to reports and documents such as Fusion Center reports, narratives, news articles, and crime analyst reports.

Kelley Stone will manage the project and will participate in presentation of the results at a conference each year. The research, development, and test will be done without the purchase of any new equipment, software or maintenance. The level-of-effort research and development is to be done by Dr. Johnson of ADB Consulting, as requested by UTD. Almost all of the work on this project will be directly applicable and very valuable to the Fusion System project, thus reducing the project costs for the County or the UASI by approximately \$325,000.
