Their mission statement is: "There's no place for family violence in Collin County". Ms. Egelston-Caso asked the Court for assistance in getting information to the public. Community members were recognized and a brief explanation of the Empty Shoe Project followed: 1925 pairs of empty shoes were lined up outside of the Courthouse to represent the number of crime victims that came through the justice system in 2008.
