#### **GENERAL DISCUSSION**

#### Presentation, discussion and any action regarding:

2-1-1 Presentation by the Community Council of Greater Dallas, Commissioners Court.

Commissioner Ward introduced Jill Cumnock, Executive Director Frisco Family Services. This organization is a part the Collin County Children's Coalition. Commissioner Ward serves as a committee member of Frisco Family Services.

Ms. Cumnock addressed the Court regarding the 2-1-1 program and to give comments on how it helps those in need. Ms. Cumnock then introduced Leslie Chatman, 2-1-1 Outreach Specialist Community Council of Greater Dallas, who spoke to the Court with more details on this program. Ms. Chatman told the Court her initial presentation contained some errors therefore she would not be showing the power point at that time.

Ms. Chatman continued addressing the Court by explaining the services provided and how they worked. When a person in need calls 2-1-1, the call will be answered by a live agent. The agent will assess the callers' needs then supply them with social services providers based on those needs. After presenting an overview of the agency, Ms. Chatman received questions from the Court.

#### NO ACTION TAKEN

Funding to LifePath Systems for mental health services, LifePath Systems.

Dr. Randy Routon, Chief Executive Officer LifePath Systems addressed the Court with commentary on the services LifePath provides to certain individuals who suffer from mental illness. At the request of Judge Self Dr. Routon gave the Court a brief overview of how LifePath and NorthStar work together. Dr. Routon explained that NorthStar treats individuals with one of three mental illnesses: Manic Depression (Bi-Polar Disorder), Major Depression and Schizophrenia. Although treatment of the illness is covered by managed healthcare, the administration costs are not covered. Because of this there is a shortfall in funding that is not provided by the State.

Dr. Routon stated one of the criterions of the program is the individual applying for assistance must be below 200% of the poverty level to qualify for services. NorthStar intended to put more providers into the system; however a large number of providers were not able to survive the current financial environment. Discussion and questions by Court members followed.

Prior to the presentation, Judge Self asked why this issue was being discussed outside the budget cycle. Dr. Rick Crawford replied that they were in a desperate situation with funding and needed the additional fund in order to continue providing service to those in need.

Dr. Crawford addressed the Court saying LifePath is looking into merging with a McKinney provider Avenues. The merger would provide the organization with a downtown clinic and proved someone that could manage fund raising. Judge Self asked why this issue was brought to the County for assistance and not the City of McKinney. Dr. Crawford he had approached the Mayor who stated this was something that was needed and he should talk to the County. Extensive discussion with Court members followed. Commissioner Ward stated that the County would at minimum adopt the same budget for these services that was adopted last fiscal year. Additional discussion followed.

Hank Wich, Director Avenues Counseling Center, addressed the Court to support the budget request by LifePath. Mr. Wich shared with the Court information about Avenues and the services they provide, which includes substance abuse and mental health counseling.

Neil and Lynn Sperry addressed the Court in support of LifePath Systems. Speaking together they explained how their family was given assistance by Avenues when it was discovered a family member had a chemical dependency.

Kathy Parker addressed the Court in support of funding for LifePath Systems. Ms. Parker gave testimonial on chemical dependency and behavior dysfunctions within her family. She told the Court of how having counseling services available enabled her to recover and lead a normal life.

After commentary from Ms. Parker, Judge Self opened the issue for discussion by the Court. Commissioner Ward asked the Court if they could vote to adopt the current budget for LifePath. The Court agreed and discussion followed.

Bill Bilyeu, Administrative Services addressed the Court regarding the adoption of a new travel policy for county staff. Mr. Bilyeu told the Court the reason for need of a new policy was to enable the Auditor to better track expense claims. Mr. Bilyeu asked the Court to clarify three issues which had raised concerns from staff county wide

- 1) Section 4.1 regarding reimbursement rates. The language used "....lodging based on double room accommodation rates..." raised concerns about requiring employees traveling together to share a room. This actually refers to the price of the room, not sharing the room with another.
- 2) Section 5.1 regarding meal expenses. It was suggested that the county allow a per diem amount instead of dictating what can be spent on each meal. Mr. Bilyeu explained that a per diem is actually taxable income and most employees probably did not want the extra amount added to their year end W2. Commissioner Hoagland commented that the policy was merely a guideline to which Mr. Bilyeu agreed.
- 3) Section 5.5 regarding meals per day. The new policy states "....snacks, candy, gum, etc, and beverages..." will not be reimbursed without clear justification that the snacks replace a meal. Judge Self replied that nothing in the document was actually a policy, the standards are guidelines, also the County needs a policy on overseas travel. Discussion followed.

Carma Cameron, addressed the Court to provide additional information for consideration. Ms. Cameron stated that they need a set policy because each department uses a different way to process travel and the County needs something more cohesive. New expenditure forms will be available to breakdown the expenses so the Auditor can see exactly what costs are spent and County's The new form will also expand the Extensive discussion transparency in government policy. regarding how travel budget dollars are spent followed.

Legislation creating Van Alstyne Municipal Utility District (MUD) No. 2.

Jim Sheppard, Collin County, addressed the Court with details regarding the approval of this item. Commissioner Jaynes and Commissioner Hoagland expressed their concerns over allowing a MUD in Collin County because it could cause a hardship on county resources at a later time when the area is developed. Commissioner Hoagland stated the court has to have a policy and that he will not support the MUD saying this would have an impact on future generations. Commissioner Jaynes agreed stating his concerns over the resources that could be needed once several hundred homes were built.

Mike Parker, Mayor City of Van Alstyne approached to address the concerns voiced by Commissioners Jaynes and Hoagland. Mr. Parker stated this MUD was entirely in the city's ETJ and their resources would be utilized to serve the homeowners. Mr. Parker continued saying the intent was to provide a different kind of MUD and that the project was approved unanimously by the City Council. Mr. Parker stated they have their own ambulance service and fire department. Extensive discussion ensued.

Don Paschall, Developer approached with comments on the benefits of allowing the MUD. Additional discussion continued.
