On Wednesday, May 27, 2009, the Commissioners Court of Collin County, Texas, met in regular session in the Commissioners' Courtroom, Jack Hatchell Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas with the following members present, and participating, to wit:

Commissioner Jaynes led the Invocation.

Commissioner Hoagland led the Pledge of Allegiance.

Judge Self led the Pledge to the Texas Flag.

President Self called the <u>Collin County Health Care Foundation</u> meeting to order at 9:30 a.m. and adjourned at 9:45 a.m.

<u>ITEM NO. 1</u> Judge Self convened the <u>Collin County Commissioners Court</u> meeting at 9:45 a.m.

DECISIONS MANDATED BY LEGAL ENTITIES OUTSIDE OF COMMISSIONERS COURT AUTHORITY:

- 1. Notification of budget adjustment(s)/amendment(s), Auditor:
- **a.** <u>AI-30103</u> \$17,400 to purchase telephone equipment and provide training to the supervisors of special caseloads such as sex offenders, Auditor. Randall Rice, Auditor's Office, addressed Commissioner Shaheen's inquiry about phones in jail, noting this item is for special telephone equipment and will be utilizing existing funds. Commissioner Shaheen wanted more information on this purchase. Judge Self noted no vote was necessary.

At the end of the General Discussion segment of the agenda Randall Rice, Auditor's Office, asked the Court if his office could re-address the earlier questions regarding additional information for this item. The Court agreed and Mr. Rice introduced Linda Riggs, Grant Supervisor for the County Auditor. Ms. Riggs informed the Court the \$17,000 was broken down into two parts: Moving \$15,000 out of Training to the Education and Conference line item for training of officers who have a special line for the sex offender cases. The remaining \$2,400 is to be moved from Consultants to the Telephone Equipment line item. This is for the purchase of five phones for five teachers. Commissioner Shaheen questioned the cost of the phones, stating it was too high. Mr. Rice addressed the concern stating the phones were voice over internet protocol (VOIP) and, therefore, cost approximately \$480 per phone.

#### **GENERAL DISCUSSION**

<u>ITEM NO. 5</u> <u>Al-30096</u> Mental health services by the North Texas Behavioral Authority and Value Options, Commissioners Court.

Alex Smith, Executive Director, North Texas Behavioral Health Authority, addressed the Court to discuss services provided by NorthStar and the criteria a person must meet to receive those services. Mr. Smith presented a Power Point highlighting NorthStar's functions and services. Judge Self asked about mobile crisis services stating that the Court had the understanding that it was not active in Collin County, yet the report showed over 1,100 calls were received.

Jack Szczepanowski, Chief Executive Officer, Value Options, addressed the question saying the call center was always in existence and that is where they saw the increase. Mr. Szczepanowski continued with additional information for the Court. Judge Self asked the Police Officers who were present if there had been a decrease in runs they had to make to Dallas, such as Green Oaks. Sergeant A.D. Paul, Plano Police Department approached the Court in response, saying he did not have the statistics but could get them from Green Oaks today.

Sergeant Herbert Conner, Mental Health Liaison, Dallas Police Department, approached to further address questions. Sergeant Conner told the Court that the reason for the mobile crisis unit was to teach families to call them first instead of the Police. This would help allow them to allocate money from their budget to other areas where it is needed. Mr. Szczepanowski gave additional comments. Commissioner Hoagland said Judge Weldon Copeland had approximately 7,000 mental commitment hearings a year. Sergeant Paul told the Court how a call is handled. Mr. Smith gave comment on after hours clinics and where they are located. Discussion with the Court continued throughout the presentation. Mr. Smith then gave the Court information on service enhancements which included service provided to inmates at the Collin County Detention Facility.

Joe Powell, Executive Director, Association for Persons Affected by Addiction (APAA) of Dallas, came forward to give information on services his agency provides to persons recovering from addiction, which also includes services to the Collin County Detention Facility to help inmates transition from jail back into the community and helps to prevent relapse. They also work with the Samaritan Inn. Mr. Powell answered questions from Commissioner Hoagland about finding

jobs for inmates returning to the community. Additional discussion followed with the Court.

<u>ITEM NO. 6</u> <u>Al-30141</u> Redistricting, Commissioners Court. Commissioner Hoagland asked that this item be held until a later court.

<u>ITEM NO. 7</u> <u>Al-30115</u> Proposed Improvements to Myers Park & Events Center with Adventure Camp Bond funds, Special Projects.

Jeff Durham, Parks and Projects Manager, addressed the Court regarding using open space bond funds for improvements to Myers Park. Mr. Durham gave a Power Point presentation listing the improvements needed, which included a restroom facility and an Amphitheater. These facilities would be used by several organizations that regularly use the Park. The request is to use some of the \$1.7 million left over from Adventure Camp bond funds.

Joe Ann Stahel, Plano, came forward. Ms. Stahel stated she was on the original Collin County Adventure Camp Advisory Board and they (the Board) had no idea there were any funds left over. Ms. Stahel stated the Board fought diligently to get everything at the Camp that was on the original plans, but had to cut some of the items because they were told there was not enough funding. Ms. Stahel continued, saying she was surprised there was money left over and that those funds should not be spent at Myers Park, they should be used to re-seed the Camp and resurface the trails that erode with every rainfall. Commissioner Hoagland commented that additional property will need to be acquired eventually and that the property by the Camp has been offered for sale to the County first. Commissioner Hoagland agreed with Ms. Stahel that the funds should be spent at the Camp.

Randall Rice, Auditor's Office, said there is no limit to the time the money can be held, as long as it is used for the specific purpose stated on the bond. Commissioner Jaynes wanted to know what had been cut for which the money could now be used.

Ann McWilliams, Consultant, addressed the Court to give comments regarding the trails at the Adventure Camp and the erosion that had taken place due to the budget cuts. Ms. McWilliams stated she had been hired by the Commissioners' Court at the beginning of the construction of the Adventure Camp and explained why the trails are washing away with each rainfall. Ms. McWilliams said she would like to see the funds used to repair and maintain the trails at the Camp.

Commissioner Hoagland suggested the Court reconstitute the original board and have them look into the issue, stating he too was surprised at the left over funds. Commissioner Hoagland then made a motion to reconstitute the original board

and have them come back to the Court with information about how best to spend the money.

<u>ITEM NO. 8</u> <u>Al-30114</u> Open Space Bond funds for the design and construction of a hike/bike trail at the Justice Center, Special Projects.

Jeff Durham, Parks and Projects Manager, remained before the Court with another Power Point presentation regarding the creation of a hike and bike trail at the new Justice Center site. He also showed drawings from the City of McKinney Trail Plan. An estimate and breakdown of costs followed: approximately \$560,000: trail design, bridge design, concrete trail, concrete paths, bridge construction, trail lights, benches, picnic tables and trash cans. Discussion followed with court members, with Mr. Durham answering questions.

Commissioner Jaynes suggested the resurrection of the Constitutional Plaza, which was just dismantled at the old courthouse, among the trees and including benches and tables for staff to enjoy the outdoors.

Mr. Durham requested monies for improvements at Myers Park and also improvements at the Justice Center. He stated there was \$2.4 million allocated for this series of improvements. The total of the two projects would be approximately \$1 million.

Judge Self called Vicki Day, Executive Director, North Texas History Center, forward to talk about activities at Myers Park. Ms. Day presented the Court with a handout and she then gave a presentation about the creation of Myers Park. Ms. Day read from the original Deed of Trust. Judge Self thanked Ms. Day for the history lesson.

Back to Mr. Durham and the improvements at Myers Park. Commissioner Hoagland was concerned about violating trust with the public with taking money for these projects. He said the Court could take the money out of fund balance so their commitment to the public was honored with park bonds. Commissioner Jaynes agreed, adding there were partners involved in the funding. Discussion followed.

Bill Bilyeu, Administrative Director, read from original bond proposal. Judge Self discussed an open space bond for hike and bike trail. Commissioner Jaynes stated he didn't want to circumvent the Open Space Board and they should present an application to the Court and go through due process. Commissioner Shaheen agreed.

Commissioner Jaynes made a motion to present two applications, to let the applications go through the Open Space process and be brought back to Court in October

Judge Self asked Mr. Durham to bring the presentation back.

Lolisa Laenger, Chairwoman, Collin County Historical Commission, approached the Court to request approval to hire a project manager for the historic assets survey. The survey is needed to locate sites before historic markers disappear. Judge Self asked for discussion on Item No. 10 at this time as well. Ms. Langer was asking for approval to set up a grant program for \$10,000 for historical groups in the county. They already have the money in their budget so they are not asking for funding; just approval from the Court to set up the program. Money will not be spent this year for either item, but will be needed to encumber funds. Ms. Langer wanted to set aside \$2,000 as an emergency fund. She requested that 2009 dollars be rolled into 2010.

Mr. Delgado asked the Court to pay for this in two parts: first are updated regulations; second is creation of a development permit fee, and he gave reasons for it and how the money would be spent. Discussion followed between Mr. Delgado and the Court. Tim Nolan, GIS, came forward with further explanation. Mr. Delgado and Mr. Nolan answered further questions from the Court. Judge Self wanted to see costs kept to a minimum.

Commissioner Hoagland made a motion to approve both. Judge Self said the Court first needed a motion adopting regulations. Commissioner Hoagland moved to adopt both items. The motion died for lack of a second.

Commissioner Jaynes made a motion to adopt the regulations of the floodplain map.

Commissioner Hoagland made a motion to institute a \$50 development permit

Judge Self asked for motion on a different amount. Mr. Delgado suggested \$20 for a flood plain development review fee. Discussion ensued.

Judge Self made a motion to set the development permit fee at \$20. Commissioner Jaynes stated he would not second and that it is duress on citizens. Judge Self stated the Court had to do something and asked what would happen if they did nothing. Mr. Delgado said if the Court did not act, FEMA could say they are not catching everybody who might build in a floodplain and issue sanctions against the County. Judge Self then withdrew his motion. Commissioner Hoagland suggested this issue be brought back to the Court when all of the Commissioners were present. Consideration of the development permit fee would be placed on a later agenda.
