Presentation, discussion and any action regarding:

AI-30184 5. No Action Taken JJAEP and Juvenile Probation Facilities, Commissioners Court. Bill Burke, Construction and Projects, gave a presentation at the request of Commissioner Shaheen regarding a plan to build a new facility for Juvenile Probation. Commissioner Shaheen commented that he thought this was unnecessary. Mr. Burke explained how the space will be used and the number of students this would provide services to. Discussion by the court followed.

Joe Scott. Director Juvenile Services, approached the court to address questions regarding the type of services that will be provided. Mr.

Scott said the teachers are employed by McKinney ISD and the Juvenile Justice Alternative Education Program (JJAEP) by statute must keep the curriculum in line for the student to graduate. Mr. Scott asked the court to approve the build out of two clusters and a shell for a third cluster. Judge Self expressed concerns regarding building out more space than is currently needed and said the court should be focusing on saving tax payer money while still providing classrooms outside the UDCF (University Drive Courts Facility) building. Commissioner Ward commented that this project was approved in a facilities bond previously so this is not above the budget and since it could be built one cluster short of what was approved they are already saving taxpayer dollars. Extensive discussion with the court continued through-out the presentation. Mr. Burke will advertise for bid at end of July.

Commissioner Ward asked Mr. Scott to elaborate on the program to inform the citizens of why we have the program. Mr. Scott explained this is required by Texas law which is governed by population in each county. The program is used in one of two situations: expulsion or persistent misbehavior. Additional discussion followed. Commissioner Hoagland stated he wanted to see all three alternatives for the sake of comparison saying if a second cluster could be built out for \$400 thousand dollars it would be foolish not to do so. The court continued with a brief discussion on the number of clusters that should be considered. Judge Self told Mr. Scott the court would give him further direction at a later date.

Emergency Interruptible Load Service Program through Electric Reliability Council of Texas (ERCOT) by TD Industries, Facilities. Barry Whaley, TDIndustries presented a power point presentation which included the history of the company and the company's group mission. Services provided include HVAC, Plumbing and Electrical Services. By using UtiliVisor software the user will have the ability to monitor and archive the energy management system. It will allow the user to compare energy usage between each of the buildings on campus. After the presentation Mr. Whaley received questions from the court. There is no cost to the county for this program. Discussion followed.

Dan James, Facilities, approached to give additional comments on the program and how it works. Collin County would be the first government entity to utilize this service to save tax payer money on the cost of running County facilities.

Judge Johnny Lewis addressed the court regarding the redistricting of Constable and JP departments. Judge Lewis presented a survey on the justice courts in 12 counties in Texas which included the number of courts and clerks per judge in each county. Eight of these are comparable to Collin County. Judge Lewis also addressed a concern from Judge Self regarding the Office of Court Administration (OCA) stating that the numbers are skewed because they do not include hearings, only the cases filed and there could be four to five hearings per case. Judge Lewis asked the following Judges and Constables to approach: Judge Terry Douglas, Pct 2, Judge John Payton, Pct 3-2, Judge Paul Rahleeh, Pct 1, Constable Paul Elkins, Pct 1, Constable Johnny Todd, Pct. 4 and Constable Chuck Presley, Pct 3. Judge Yarborough, Pct 4 could not attend due to his court docket. Judge Lewis continued with the presentation saying Collin County JP courts do not have visiting judges. Judge Lewis gave the court future estimated cases if a redistricting was approved.

Judge Self introduced Constable Joe Barton who submitted a blue card regarding this issue. Constable Barton addressed the court with commentary to express his opposition to the plans submitted. He also expressed his concern for the citizens of Collin County who do not know about these plans, and said he did not have enough staff to cover the additional areas the redistricting would bring to his precinct.

Constable then told the court they should leave the districts as they currently are. Judge Paul Rahleeh gave comments on his thoughts as did Constable Paul Elkins who stated he had no problem with the changes. Judge Rahleeh stated the court asked th Judges and Constables to find a solution and they did; and he requested the approval of modified plan 8b. Extensive discussion with the court followed. Constable Chuck Presley approached to inform the court that if this is approved he will submit a proposal for additional staff. Additional extensive discussion followed including all parties. Commissioner Shaheen said he pulled his own numbers which did not include traffic cases.

Constable Todd gave comments stating he was agreeable with the proposal but not with eliminating any deputies. He said there are eight in his office and if the proposal is approved they could finally catch up on the workload.
