concerns about the cost of the program, estimated at \$160,000. Ms. Jacobson stated the County's EAP is offered at no cost to the County through United Health Care. Commissioner Hoagland, who was in support of the program, wanted to know if a pilot program could be offered to the Sheriff's department, which has 480 employees, at a reduced cost. Commissioner Jaynes made a motion that Commissioners Shaheen and Hoagland work with Marketplace Chaplains, the Sheriff's office and the Budget Department to explore this further. Judge Self had concerns.
