THEREFORE, by the virtue of the authority vested in me by law, I, Chris Oldner, Administrative Judge in and for Collin County, Texas, and IT IS ORDERED that the position of Caseworker be, and is hereby established within the Community Supervision and Corrections Department in and for Collin County, Texas, IT IS FURTHER ORDERED that MS. MELISSA GUERRERO be, and she is hereby appointed to the position of a Caseworker (#650-6101), her term of office to begin on the 27th day of July, A.D., 2009; IT IS FURTHER ORDERED that MS. MELISSA GUERRERO shall receive as compensation for the performance of the duties incumbent upon this office the salary of \$29,869.00 (grade 533, step 1) per annum, which sum of money shall be paid to her in twenty-six (26) equal installments out of the 199th, 219th, 296th, 366th, 380th, 401st, 416th 417th, and 429th Judicial District Fund of Collin County, Texas; and in addition, IT IS ORDERED that MS. MELISSA GUERRERO receive \$0.55 per mile for travel expenses out of the same Judicial District Fund;


