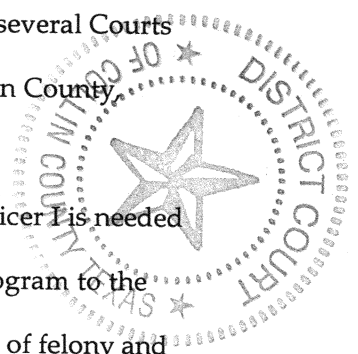

misdemeanor offenders, will suffice to meet the minimum requirement under the Government Code, Chapter 76, Section 76.005; Standards for Officers.

And it further appearing to the several Courts that MS. LIBBY MAYS having graduated in 1997 from the Florida State University of Texas with a BS degree in Criminal Justice, having previously worked as a supervision officer for Collin County CSCD from 1997 – 2002, is in all things a qualified person to hold the position of a Supervision Officer I in the Community Supervision and Corrections Department in and for Collin County, Texas;

THEREFORE, by the virtue of the authority vested in me by law, I, Chris Oldner, Administrative Judge in and for Collin County, Texas, IT IS ORDERED that MS. LIBBY MAYS be, and she is hereby appointed to the office of Supervision Officer I (#650-6101 Basic), her term of office to begin on the 17th day of August, A.D., 2009.

IT IS FURTHER ORDERED that MS. LIBBY MAYS shall receive as compensation for the performance of the duties incumbent upon her office, the annual salary of \$35,183.00 grade 535, which sum of money shall be paid to her in twenty-six (26) equal installments out of the 199th, 219th, 296th, 366th, 380th, 401st, 416th, 417th and 429th Judicial District Fund of Collin County, Texas; and in addition, IT IS ORDERED that MS. LIBBY MAYS receive \$0.55 per mile, out of the same District Fund for travel expenses; and finally, IT IS ORDERED that the District Clerk shall certify this ORDER to the Human Resources Department, Payroll Division of Collin County, Texas, for the compliance therewith effective the 17th day of August, A.D., 2009.
