On Monday, September 28, 2009, the Commissioners Court of Collin County, Texas, met in regular session in the Commissioners Courtroom, Jack Hatchell Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas with the following members present, and participating, to wit:

Judge Self led the Pledge of Allegiance.

Commissioner Shaheen led the Pledge to the Texas Flag.

1. Judge Self called to order the meeting of the **Collin County Commissioners Court** at 9:30 a.m.

Judge Self recessed the meeting of the Collin County Commissioners Court at 9:41 a.m. and called to order the meeting of the Collin County Housing Finance Corporation.

President Self recessed the meeting of the Collin County Housing Finance Corporation 9:47 a.m. and called to order the meeting of the Collin County Helath Care Foundation.

President Self recessed the meeting of the Collin County Health Care Foundation at 9:47 a.m. and called to order the meeting of the **Collin County Toll Road Authority.**

President Self recessed the meeting of the Collin County Toll Road Authority at 9:48 a.m. and reconvened the meeting of the Collin County Commissioners Court.

Judge Self returned to this item at 12:08 p.m. and stated the item would be pulled from today's agenda awaiting additional information from Mr. Ybarbo. (Time: 12:08 p.m.)

Cindy Johnson, McKinney, Texas, came forward. Ms. Johnson is the Executive Director of the Heritage Guild of Collin County. She stated she participated in Collin County's Historical Commission's grant program; however, she did not

receive any grant monies. Ms. Johnson was disappointed with how little funding was allocated to the historical museums in Collin County. She gave background on the history of the museums, highlighting the fact that the number of visitors increases as the county grows. Ms. Johnson asked the Court to continue their support of the Heritage Guild. (Time: 9:52 a.m.)

Velynda Short, Anna, Texas, spoke on behalf of several residents who live off of County Road 376. Residents had been told in 1997 that CR 376 would be paved, and as a result they gave up easements with no reimbursement. To date, the work has not been done. Ms. Short stated dust and dirt from the road aggravates her allergies and asthma. Also, the roads are very hazardous and slippery. Ms. Short stated that Philip Sanders, City Manager, City of Anna, has told the residents their road is not a priority. Ms. Short stated the community has come together to demand their road be taken care of. They have been told the cost to complete the work is \$10,000 and they will be meeting with the City of Anna to see if they can complete this project. Ms. Short presented the Court with a petition signed by the property owners which she read to the Court.

Peggy Gigi Lisai, Anna, Texas, is also a resident of County Road 376. And Ms. Lisai also stated her allergies are worse due to the dust and dirt. She was speaking on behalf of her parents who wanted her to address the subject of why they had to give up five feet of their property in 1997 to get the road paved. If the project is not going to be done, they would like to get their property back.

Commissioner Jaynes stated since this is a county road outside the city limits, (half is in the county and half is in the city) the county has to enter into an interlocal agreement with the city by law. The City of Anna will be meeting with their Economic Development Corporation this week to see if they can come up with the funding.

Philip Sanders, City Manager, City of Anna, was present to speak on behalf of the TIRZ policy, but first addressed Ms. Short's and Ms. Lisai's concerns. He stated Jon Kleinheksel, Public Works, has been very kind and has been asking for Anna's participation. The City of Anna is working with Public Works to get this project completed.

Ms. Sanders then turned his attention to the TIRZ policy, reiterating concerns raised by the City of Anna at prior public meetings. The City of Anna is requesting that items 4a and 5 be eliminated from the policy as they will have a negative impact on their opportunities to do business.

Commissioner Hoagland suggested this item be held until he and Commissioner Ward can have a meeting and they will invite the Cities of Anna and Plano to come back before the Court if necessary. Commissioner Ward agreed. Commissioner Jaynes stated he is waiting for feedback from representatives from the Cities of Frisco and McKinney.

Colleen Egan, McKinney, Texas, was present to speak on item 4c7 as a private citizen and as a member of the Parks and Open Space Board. Ms. Egan asked the Court for their consent to the scope of surfaces for the Collin County Regional Trails Master Plan. She has created a resource which she presented to the Court which pulls together all of the parks and open space plans and trail plans for all the entities in Collin County. She asked the Court to support this plan, stating it was forward thinking. Judge Self had some questions and commentary. Ms. Egan answered questions from Judge Self. Commissioner Jaynes asked to see a map and had questions as well. Commissioner Hoagland offered explanation of the plan.

Commissioner Hoagland made a motion to approve item 4c7. Judge Self wanted that item pulled for discussion. Commissioner Shaheen questioned the necessity of paying an engineering firm \$200,000 vs. having all the cities get together and create a coordinating plan connecting all of the cities' trail plans. Discussion followed. Ms. Egan agreed with Commissioner Shaheen's suggestion and stated that might be the next step.

Judge Self had a blue card from Zelda Goldwyn, McKinney, Texas, who did not choose to speak but wanted it noted she was in support of item 4c7.

Judge Self expressed his concerns to paragraph 1.9 regarding "opportunities". Jeff Durham, Parks and Projects Manager, stated Ms. Egan did a good job explaining the history of the plan, how it has evolved and where we are today. The purpose is to have a planning document for not only the county, but for all the cities to use as well. Commissioner Shaheen felt a regional trail plan for the county is an idea with merit, and then asked if it be can be brought back before the Court. Commissioner Jaynes wanted a history of where they are with the open space plan and asked that it be put on the next workshop session. Commissioner Ward wanted to see how this would tie in with the Outer Loop. Commissioner Shaheen recognized Mr. Durham's efforts in getting an \$85,000 reduction in engineering costs. Mr. Durham stated the costs were reduced from \$298,000 to \$194,000, which is a 35% reduction. Discussion followed between Commissioners Jaynes and Shaheen.

Commissioner Hoagland withdrew his motion. The item will be placed on a future work session. (Time: 10:28 a.m.)

Judge Self noted Sarah Wells Macias submitted a blue card in support of the Collin County Farm Museum.

Roy Serpa, Fairview, Texas, first complimented the Court on their discussion in a prior meeting of the vacancy in County Court at Law No. 4 and their efforts to be fair and open. Second, he stated he had read in minutes from a prior Court that the County Commissioners will be coming up with objectives and he was curious

as to what those objectives would be and how those objectives would effect the budget. (Time: 10:30 a.m.)

Misty Brown, Development Services, came forward to recognize two rescue friends for their assistance with the placement of 24 rescued dogs that were found in deplorable, inhumane conditions. Mary Ann Nastro and DeDe Whitcombe gathered supplies and resources to save the lives of these animals and find them homes. Ms. Nastro said she wished they could save all the animals that come through the doors of Collin County's Animal Shelter. Judge Self thanked them for their efforts. (Time: 9:34 a.m.)

Jon Kleinheksel, Public Works, recognized three employees for their service to Collin County: Pat Howell, 15 years of service, equipment operator; Geoff Crouch, 25 years of service, equipment operator and head of the storm water program; Forest Cox, 25 years of service. Mr. Kleinheksel stated these employees are a huge asset to Collin County. (Time: 9:36 a.m.)

County Clerk Stacey Kemp presented pins to Minnie Springs, Public Assistance, for 25 years of service and Deborah Brannon, Indexer/Bookkeeper, for ten years of service to the citizens of Collin County. Ms. Kemp complimented them both for being outstanding employees. (Time: 9:37 a.m.)

John Roach, District Attorney, recognized Novaline Varner for 25 years of service. Ms. Varner is the Chief Criminal Investigator in the D.A.'s office and she also heads up the cold case unit. (Time: 9:39 a.m.)
