1. Judge Self called to order the meeting of the **Collin County Commissioners Court** at 1:00 p.m.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation Board of Trustees</u> at 1:42 p.m.

President Self called to order the meeting of the <u>Collin County Toll Road</u> <u>Authority Board of Directors</u> at 1:43 p.m.

Judge Self reconvened the meeting of the **Collin County Commissioners Court** at 2:39 p.m.

DECISIONS MANDATED BY LEGAL ENTITIES OUTSIDE OF COMMISSIONERS COURT AUTHORITY:

Commissioner Hoagland wanted it noted that taxpayers are being asked to pick up the cost of \$286,000 this week without any oversight from county government. Commissioner Jaynes said he wants these amounts posted on future agendas for the public. (Time: 2:39 p.m.)

2. Public Comments.

Shawn Stevens, Chairman of the Democratic Party of Collin County, came forward to speak in opposition to Item 4k3, appointment of election judges for early voting locations and election day vote centers. Specifically Mr. Stevens was opposed to James Middleton being re-appointed as an election judge. Mr. Stevens stated Mr. Middleton committed a misdemeanor on October 31, 2008, by illegally obstructing poll watchers from being able to observe election activity in the polling location to which they were assigned. Mr. Stevens stated Sharon Rowe, Elections Administrator, told him Mr. Middleton would not be serving as an election official after this incident. Mr. Stevens answered questions from Court members.

Debra Hyatt, Richardson, Texas, said she was one of three poll watchers who dealt with Mr. Middleton. She stated Mr. Middleton told her he did not want her at the polling location. She was told to sit in a particular chair, to not move and not ask any questions. She said she was told if she did ask a question, the police would be called. Mr. Middleton's son and wife both got upset with Ms. Hyatt as well because she looked at the computer screen when they were telling an inexperienced voter that he had to go to Dallas County when he was in the system for Collin County. Ms. Hyatt concluded by saying this is just one of many incidents involving Mr. Middleton.

Linda Magid, Allen, Texas, was another one of the three poll watchers involved in the same situation. Mr. Middleton told Ms. Magid to stand in a corner and not do anything. She was told if she interrupted or disturbed anything, the police would be called. Ms. Magid stated she felt threatened and could not see or hear anything which precluded her from doing her job. Mrs. Middleton also made it very difficult for Ms. Magid to do her job. Ms. Magid also stated Mr. Middleton tried to have a person removed who was outside, in an designated area, handing out flyers, saying he could not do that which is not true. Ms. Magid felt that Mr. Middleton should not be allowed to serve as election judge.

Deborah Angell Smith, Allen, Texas, is a former Chairwoman of the Democratic Party of Collin County. She stated she was called into a situation that occurred in 2004. Ms. Smith stated she attended all of the trainings in 2004 where Sharon Rowe, Elections Administrator, talked about poll watchers and how they were to be dealt with. Ms. Smith was told that Mr. Middleton's location was turning away a large number of people, predominantly people of color; therefore, she sent a poll watcher out to the location but Mr. Middleton refused to admit her. Ms. Smith then went to the location herself as a poll watcher and she was told where to sit and told to stay there. Ms. Smith felt Mr. Middleton and his family should not be re-appointed as election judge or election officials.

Sharon Rowe, Elections Administrator, came forward to explain the appointment process and the ability to find election judges. She spoke about the incident in 2004, stating it was the first election in which poll watchers were appointed by party chairs. She explained the process for removing a person from the nomination list. The question that has to be answered is: do nominees meet the eligibility requirements to be an election judge? If a situation is brought to Ms. Rowe's attention, she addresses it with the election official. Ms. Rowe continued with her explanation. Ms. Rowe relayed conversations she had with Mr. Stevens. Ms. Rowe stated Mr. Middleton had told her he would not work again as a poll watcher. Additionally, she spoke with Fred Moses, Chairman of the Republican Party of Collin County. It was determined Mr. Middleton met eligibility requirements; therefore, Mr. Moses was not asking that Mr. Middleton's name be withdrawn. Ms. Rowe answered questions from the Court. Ms. Rowe said in order to make changes in policy would require new election laws. Commissioner Jaynes asked Ms. Rowe to continue to monitor the situation. Commissioner Hoagland made a motion to approve item 4k3 as written. Commissioner Shaheen stated he would vote against this item. (Time: 1:42 p.m.)
