On Monday, November 9, 2009, the Commissioners Court of Collin County, Texas, met in Regular Session in the Commissioners' Courtroom, Jack Hatchell Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas with the following members present, and participating, to wit:

Judge Self called to order the meeting of the Collin County Commissioners Court at 9:30 a.m. and recessed at 9:37 a.m. to call to order the Collin County Health Care Foundation.

President Self called to order the meeting of the <u>Collin County Health Care</u> <u>Foundation Board of Trustees</u> at 9:37 a.m.

President Self called to order the meeting of the <u>Collin County Toll Road Authority</u> <u>Board of Directors</u> at 9:37 a.m.

Judge Self reconvened the Collin County Commissioners Court meeting at 9:52 a.m.

# DECISIONS MANDATED BY LEGAL ENTITIES OUTSIDE OF COMMISSIONERS COURT AUTHORITY:

1. <u>Al-30956</u> Utilization of the Drug Forfeiture Account to supplement the salaries of all the DA employees required to have a County cell phone to cover the \$15 per month payroll deduction for a total of \$5,148, District Attorney.

Commissioner Hoagland asked about the \$15 charge. Cynthia Jacobson, Human Resources, approached to answer the question saying this deduction covered personal use on the County issued phones. Commissioner Hoagland stated he didn't think this was a valid use of the funds and would not support it. He continued saying he wanted to vote against the item. Judge Self stated this was an FYI item; therefore, no action would be taken. Commissioner Hoagland made a motion to authorize the County Auditor to look into the utilization of funds and see if this is a legal use of the funds. Commissioner Shaheen seconded the motion. Jeff May, County Auditor, stated he would look into the matter and said he did not need a vote to do so. After a brief discussion among Court members, the second was withdrawn. Commissioner Jaynes said he would not second the motion, but he did want the Auditor to come back with information regarding the statute on the utilization of the funds. Motion died for lack of a second. (Time: 10:06 a.m.)

Mr. Middleton read a statement defending his actions. Judge Self told Mr. Middleton that since this was not an agenda item the Court could not comment or take any action. (Time: 10:00 a.m.)

Commissioner Shaheen said he needed a better understanding of Geomarine, the firm involved with the study. Ruben Delgado, Engineering, addressed the Court regarding Geomarine. Mr. Delgado stated Geomarine is a firm who conducts environmental work and they consist of not only Engineers, but also Anthropologists. When an object such as an arrowhead or a chart is found that could have come from Native American people, they point it out and mitigate it. Mr. Delgado said this item was a joint project between the County, the City of Wylie and TxDOT and the County is bound by statute to continue the archeological study and to mitigate.

Extensive discussion with the Court followed. Judge Self stated this was a 1999 bond project and asked if these funds were still available. Mr. Delgado said yes, there is approximately 650 thousand dollars available. Motion to approve item. (Time: 10:11 a.m.)

The committee wants a report on Purchasing at the end of December, Engineering at the end of January and Public Works at the end of February. Criminal Justice was not scheduled at this time. The reports would include operational and functional descriptions, process maps, recommendations for improvement, detail implementation plans and a schedule when the improvements should be completed. The report would also include a detail on the cost savings to the County. Commissioner Jaynes said he wanted an update on the committee's meetings, such as when the meetings are held, who attended, etcetera. Commissioner Jaynes asked why the County's Web Master, Larry Jones, was the point person for the committee.

Caren Skipworth, Information Technology, approached to reply saying Mr. Jones represented the County and works with departments regarding the website as well as

conducting efficiency work within the Information Technology department. Discussion with Court members continued throughout the update. (Time: 10:25 a.m.)

# 9. Al-31064 Health Benefits, Human Resources.

Cynthia Jacobson, Human Resources, approached with additional information at the request of the Court regarding the County's benefit plan. Ms. Jacobson gave a power point presentation which included a breakdown on the costs of the top five claims. Information on the Large Loss Claims included a breakdown on each condition involved and the number of cases in each category as well as the cost per claimant. Preventative tests and the cost of each test, which are available to the employees, were also shown to the court. Questions and discussion with the Court members continued throughout the presentation.

The top five claims listed were:

Circulatory-hardening of the arteries, valve disorder, etcetera. Cancer-breast, ovarian/uterine/cervical and lymphoma Musculoskeletal-disc disorder, arthritis Digestive-non-diabetic pancreatitis, liver disease Injury/Poisoning-implant complications (knee) and fractures

Ms. Jacobson reiterated information from her annual benefit presentation which she presented to the Court on October 26, 2009.

At the request of Commissioner Hoagland, Candy Blair, Health Care, approached the Court and answered questions regarding tests provided by the employee clinic.

Ms. Jacobson continued saying the majority of the health issues seen are lifestyle choices. An example of these choices per 100 employees was shown, Commissioner Jaynes clarified that the numbers shown were generic from the Department of Health and Human Services and not an example of the County's employees. Ms. Jacobson informed the Court that annual wellness exams do not require a co-pay so long as the employee has not exceeded the annual \$750 benefit.

The presentation ended with a slide showing a contribution survey with the County's peers, which was at the request of Commissioner Hoagland. Judge Self opened the floor for discussion. (Time: 10:57 a.m.)
