On Monday, November 16, 2009, the Commissioners Court of Collin County, Texas, met in regular session in the Commissioners Courtroom, Jack Hatchell Administration Building, 4th Floor, 2300 Bloomdale Road, City of McKinney, Texas with the following members present, and participating, to wit:

Judge Self led the Invocation.

Commissioner Shaheen led the Pledge of Allegiance.

Commissioner Hoagland led the Pledge to the Texas Flag.

<u>ITEM NO. 1</u> Judge Self called to order the meeting of the <u>Collin County</u> Commissioners Court at 9:30 a.m.

Judge Self recessed the meeting of the Commissioners Court at 9:34 a.m. and convened the meeting of the **Collin County Health Care Foundation**.

Judge Self reconvened the meeting of the **Collin County Commissioners Court** at 9:49 a.m.

Commissioner Ward read a proclamation signed by the Collin County Commissioners honoring Sergeant Kimberly Munley, a U.S. Department of Defense Police Officer, Fort Hood, Texas, for her acts of bravery and heroism on November 5, 2009, and declaring her an honorary resident of Collin County. Judge Self told Ms. Johnson that she had three minutes to speak; however, since this item was not on the agenda, the Court would not be able to make comment or take action. Erica Johnson, Parker, Texas, came forward and spoke about Plano Independent School District's plan to build two new schools and create new school boundaries. Ms. Johnson feared the new boundaries being drawn will cause segregation as a result of children being bussed to schools that are not the closest schools to their homes. (Time: 9:55 a.m.)

3. Consent agenda to approve. Judge Self asked if any member of the Court or any member of the audience had an item they wanted pulled from the consent agenda for individual consideration. Commissioner Hoagland pulled items 3b and d5 and Commissioner Shaheen pulled items 3f1 and 3j3. Commissioner Jaynes made a motion to approve the remainder of the consent agenda. (Time: 9:57 a.m.)

Commissioner Hoagland wondered why these bids were rejected. Bill Burke, Building Projects Manager, said he was directed by a previous Commissioners Court decision to go back and renegotiate with all bidders. Negotiations with two were rejected as not meeting the criteria specified in Court; the third lowest bidder gave conditions upon which his bid was good but was not acceptable; and

the fourth bidder also did not meet the criteria. As a result, his department is in the position where they need to reject all proposals. Although he was directed to get the price down to the lowest bid, the lowest bid was not necessarily the best bid. Mr. Burke answered questions from the Court. Mr. Burke concluded by saying bids one and two were approximately \$1 million higher than bid three. The County will be ready to re-advertise in early January. Commissioner Hoagland made a motion to approve. (Time: 9:58 a.m.)

GENERAL DISCUSSION

4. <u>AI-31106</u> Waive the required 60-day notice for a public hearing to expand the boundaries of the TIRZ No. 1 and amend the project and financing plans, City of Frisco.

Nell Lang, Assistant City Manager, City of Frisco, spoke as liaison to the TIRZ Board. The Board met on October 20th, but Commissioner Shaheen was not able to be present at that meeting. At that time they approved enlargement of the boundaries. The changes that were proposed at that meeting were outlined and

presented to the Court by Ms. Lang. Ms. Lang stated they have called a public hearing for December 1st and requested the Court waive the required 60-day notice. Commissioner Shaheen had questions about expansion of boundaries. Ms. Lang said it is exempt property. Judge Self had a question about the last waiver and approval of a public hearing in 2008, asking if this requires an amended contract. Ms. Lang said no, it doesn't affect the County's contract. Commissioner Shaheen stated he was fine with this request and made a motion to approve. (Time: 10:11 a.m.)

Caren Skipworth, IT, had a Power Point presentation entitled "Collin County IT, Planned Odyssey Jail Management Efficiencies". By way of status update Ms. Skipworth stated the CJIS jail and sheriff's office project team has been working diligently daily on configuring and getting Odyssey installed. They are not at the point to where they are configuring what will be presented in Court today. IT has identified quite a few efficiencies that will be saved with the new system coming in, mainly between prosecution, clerks and the jail.

Ms. Skipworth continued with the Power Point presentation, itemizing and describing current processes and future efficiencies. Ms. Skipworth answered questions from Court members. She stated Judge Oldner requested a six-month delay until OCA problems are resolved. Judge Self stated he did not think everyone should be delayed as completion of this project brings better service to our citizens. Ms. Skipworth added postponements cost money. Ms. Skipworth continued with her presentation and discussion followed. Commissioner Hoagland requested a list of the items that needed to be streamlined. Commissioner Shaheen asked that a dollar amount be attached to the ten areas discussed, especially in the area of final sentencing which will reduce the number of days someone is in prison, at a cost of \$70 per day, following final sentencing. Monika Arris, Budget, said her office is on board with moving to the new technology. Ms. Skipworth concluded by saying the contract with Tyler Technologies has been extended to December 2010. The project must be completed by that time. (Time: 10:37 a.m.)
