Judge Self responded saying Mr. Kleinheksel answered the question he had because the report submitted to the Court today included some words that sounded negative. Judge Self asked for verification that

the County had positive control over inventory. Mr. Kleinheksel said yes, there was positive control over inventory and always had been. Jeff May, County Auditor, gave comments saying he was very satisfied with the new process. Judge Self said he just wanted the clarification that the County's internal controls were tight. Judge Self asked if this would provide congestion relief or economic development. Commissioner Shaheen said it would provide both although, as a matter of timing, the economic development would come first. Commissioner Shaheen continued saying he didn't think the Court had to make a decision now he just wanted to see if the Court agreed with looking into the feasibility of the west side. Commissioner Jaynes stated that the next RTC meeting would be held on December 10, 2009 and, at that time, they would get an update on the balance of the funds including interest earned so the Court would know how much was available. Commissioner

Jaynes said he estimated the balance to be approximately 40 million dollars and suggested the Court wait on a decision until January so they had complete information as to what they could and could not do and how much funding would be available. Discussion and comments with the Court followed.

Commissioner Hoagland asked Ruben Delgado, Engineering, how much it cost for the east side of the tollway. Mr. Delgado approached in response saying the east side cost roughly 10.5 million dollars; however, the County still needed five right of way spans, only 39 out of 44 have been obtained. Discussion with the Court followed. Motion to submit researching the addition of the west side of the Dallas North Tollway as a project. Commissioner Jaynes suggested waiting until January to approve the project because on December 10th the Court would have an update on the RTR funds and would know how much would be available, and then the Court could decide on submitting the project. Motion revised to have Engineering move forward with right of way acquisition and traffic counts. (Time: 9:51 a.m.)
