Director Hoagland called the meeting of the **Collin County Toll Road**Authority to order at 9:45 a.m.

GENERAL DISCUSSION

Presentation, discussion and any action regarding:

Outer Loop, Engineering, Ruben Delgado, Engineering, came forward 2 with Will Barresi, P.E., CH2MHill, to discuss an alternative alignment analysis for Section 2 of the Outer Loop. Mr. Barresi walked the Directors through Section 2 of the Outer Loop which covered the Rockwall County line up to FM6. Mr. Barresi stated the purpose of his Power Point presentation was to update the Directors on what CH2MHill has been doing to date. Additionally, they would like to have a public meeting in August. At the request of Director Hoagland, Mr. Barresi stated he would meet with the City of Nevada. Additional questions followed from the Board of Directors and were answered by Mr. Barresi. Mr. Barresi directed the Board to an aerial map which highlighted the alternatives he was discussing. Director Shaheen moved to approve the alignment recommended by Mr. Barresi, Director Jaynes seconded, and the motion passed with a 4-0 vote of the Board.
