President Self called the **Collin County Health Care Foundation** meeting to order at 9:30 a.m.

Commissioner Shaheen requested that item 2e be held until the June 15th Workshop in Wylie due to the fact that he has received several requests from citizens who would like to offer public comment and would like to have more time to prepare. Commissioner Hoagland pulled 2b; c and d. President Self stated there present who would like to offer public were citizens Dan Dodd, Chairman, Democratic Party of Collin County, came forward to speak on item 2e. Mr. Dodd had a concern that the proposed application guidelines would shut down volunteer operated county clinics.

Shannon Fitzgerald, St. Elizabeth Ann Seton and Collin County Interfaith, thanked the Court for pulling item 2e and postponing the hearing to a time when more people could attend due to this being such an important issue to the residents of Collin County.

Margaret Langteau, represented a group of concerned citizens through an organization called Healthcare Committee of Collin County. Ms. Langteau stated a lot of people feel we need to take a long supportive look at what all caregivers in our community give and they would like to have more input and a say in what is going on. Ms. Langteau requested a public hearing to be held in the evening.

President Self stated the Court would address this item at the June 15th Workshop in Wylie City Hall at 6:00 p.m.

John Ernst, Executive Director of Collin County Adult Clinic, one of the non-profit clinics which will be discussed at the June 15th Workshop. The mission of the Collin County Adult Clinic is to serve Collin County's indigent population through an all volunteer staff. Mr. Ernst asked the Court to commit to using dollars as efficiently as possible to allow them to best serve their patients.

President Self asked for a motion on the remainder of consent agenda.

President Self stated the Board would not vote on item 2b, and since there was no further discussion and no reason to recess into Executive Session, the meeting was adjourned.
