Following completion of work within the temporary construction easement area described in Exhibit "B", if Collin County, its agents, contractors, successors and assigns, has removed or damaged improvements including fences, herbage, permanent vegetation or landscaping within said easement area or otherwise on Grantor's property, County shall at its expense restore Grantor's property removed or damaged by County's activities to equal or better condition as existed previous to Collin County's, its agents, contractors, successors and assigns entry upon Grantor's property.

This temporary construction easement shall be in full force and effect at all times during the accomplishment and completion of the construction activities described above. Said temporary construction easement shall terminate and the licensed land area shall revert to the Grantor, their heirs, and assigns, and all interest conveyed herein shall cease on the 30 day of 500 above, whichever occurs first.


