Contractor shall cooperate fully in furnishing emergency standby coverage, as requested by law enforcement agencies, and fire departments during events where firefighters or law enforcement personnel may be subject to injury. Such standby coverage may be furnished utilizing already on-duty ambulance units, and shall be furnished without additional compensation to Contractor, provided however, nothing in this shall prevent Contractor from seeking relimbursement for the actual transportation of such personnel.

Section 7.32.5 Revision

Change To:

Contractor shall cooperate fully in furnishing emergency standby coverage, as requested by law enforcement agencies, and fire departments during events where firefighters or law enforcement personnel may be subject to injury. Such standby coverage may be furnished utilizing already on-duty ambulance units, and shall be furnished without additional compensation to Contractor, and without seeking reimbursement from the individual, for treatment and/or transportation of such personnel while on scene, enrooted to the scene, or an hour after the incident.
