- 2) Section 01210 Allowances lists a \$90,000 allowance for signage, but during our walk through we discussed us (the GC) getting pricing direct from the 3 signage companies listed and doing away with this allowance. Can you please confirm this is the correct approach?
- 3) Page 15 of 74 in the Bid Packet item 1.42 states that "the general contractor shall pay for all permits..." but line B states the owner will be responsible for the permit and all impact fees. Which is correct? What will the GC be responsible for paying?
- 4) A2.21, A2.22, A2.23, A2.24 indicates several note "12's" (floor hatch) that point to what looks like ridges note "11" Please confirm this is a typo. (Submitted: Jan 22, 2010 3:49:45 PM CST)

#### **Answer**

- 1. There are no wire mesh partitions.
- 2. Per addendum #6 (see summary page) the signage allowance does not apply.
- 3. Per item 1.42 owner will be responsible for the initial building permit and impact fees. All other permits will be responsibility of the Contractor.
- 4. Yes, these are ridges and should be tagged "11". Note 12 is correctly shown on A2.22 column line E/7.5 and A2.23 column line C/5. (Answered: Jan 22, 2010 4:56:59 PM CST)
- additional info 4. Sheets A2.21, A2.22 and A2.23 will be issued in Addendum No. 8 with corrections noted.

#### **Question 24**

Several questions regarding the Acoustical ceilings.

1) Details #23 & #24 on Pg. A3.50 show wood panel suspended clgs. which occur at various locations.

My question is there is no Spec. section covering these ceilings, could you supply us with a specific product required.

2) On the Ref. Clg. pgs the legend calls for 2X2 Cirrus and Anti. micro. panels.

There is section 09511 which may apply to the Cirrus but there is no mention in this section of any tile, or

grid type. Cirrus comes in many types, is it lay-in, reveal edge or what type, and for what type grid.

Armstrong item numbers would clarify greatly.

The section 09540 Anti-micro is very complete. The question I have on this is where are these types to be installed. The room finish schedules do not show ceiling types.

The legend on the RCP pages shows. a black areas for these types, the same blackened areas correspond on the floor plan so there are no room numbers. Can this be correct? I would assume there is no work in these areas. (Submitted: Jan 27, 2010 1:52:39 PM CST)

## **Answer**

- 1. Response: Previous question 85.4 response was "85.4. This is finish carpentry." No system was specified for this specialty item. Should a potential bidder want to submit a system as an acceptable substitution, please so so as a reference to 09511.
- 2. The ceiling tile, as indicated in Addendum No. 4 is to be Cirrus square lay-in 15/16" acoustic ceiling tile 574.

The anti-microbial ceiling tiles are to be installed as the only ceiling tile installation of the entire cafeteria as shown on A3.04. (Answered: Jan 29, 2010 8:44:12 AM CST)

## **Question 25**

Reference Section 00310 Bid Form, Unit Prices. There are two scheduled carpet types and three scheduled VCT floor types. Which specific carpet and VCT types are to be used for Unit Price purposes? (Submitted: Jan 27, 2010 3:57:54 PM CST)

Should Von Duprin devices be bid for the interior to be consistent and match the existing or does the County want Sargent provided as a no substitution, sole source product? Do you have any specifications on this cpu or dvd player. is there an audio video technician working on site. please advise. (Submitted: Jan 28, 2010 8:46:01 AM CST)

- 2) Or, is the Signage and Graphics package to be purchased and installed under this contract by the General Contractor, including all costs for the Signage and Graphics package in this bid? (Submitted: Jan 28, 2010 2:17:03 PM CST)
