forfeiture funds. Monika Arris, Budget, came forward and answered questions from Court members. Judge Self asked Ms. Arris to return to a future Court with a formalized agreement. (Time: 9:37 a.m.)

GENERAL DISCUSSION

5. <u>Al-31516</u> Update from the North Texas Groundwater District, Commissioner Precinct 3.

Collin County's three appointees to the North Texas Groundwater District approached the Court. Commissioner Jaynes stated the appointees were visiting the three counties in the district to update them on where the district is and where it is going. Eddy Daniel, President of the North Texas Groundwater District, stated they had nothing formal to present to the Court today. They just wanted to report in to the Commissioners to let them know they were organized, active and following their commission in accordance with the house bill that was passed. They've formed their bylaws, rules and permitting. The North Texas Groundwater District includes Denton, Collin and Cooke counties. Mr. Daniel stated they will provide the Court with agendas for their meetings. Funding was discussed, with Mr. Daniel stating there were issues regarding loans the three counties have committed to the District to get them started. Questions followed from Court members. Commissioner Hoagland agreed they needed funding to get started. Judge Self said Brian Sledge, attorney for the Groundwater District, wrote a letter; however, since all the Commissioners did not receive the letter, he wanted to bring this matter back to the next Court following review of the letter by the entire Court. Mr. Daniel said as long as they know funding is pending, that will give other counties the impetus to move forward. (Time: 9:46 a.m.)
