1.0.1.6 RFP: refers to Request For Proposal.

1.0.1.7 RFI: refers to Request For Information.

1.0.1.8 CSP: refers to Competitive Sealed Proposal

1.0.1.9 Quotation: refers to Request for Quotation

2.2 No oral statement of any person shall modify or otherwise change, or affect the terms, conditions or specifications stated in the resulting contract. All Amendments and/or Change Orders to the contract will be made in writing by Collin County Purchasing Agent.

2.3 No public official shall have interest in the contract, in accordance with Vernon's Texas Codes Annotated, Local Government Code Title 5, Subtitle C, Chapter 171.

2.4 The Vendor/Contractor/Provider shall comply with Commissioners' Court Order No. 96-680-10-28, Establishment of Guidelines & Restrictions Regarding the Acceptance of Gifts by County Officials & County Employees.

2.5 Design, strength, quality of materials and workmanship must conform to the highest standards of manufacturing and engineering practice.

2.6 Bids/Quotes/Proposals must comply with all federal, state, county and local laws concerning the type(s) of product(s)/service(s)/equipment/project(s) contracted for, and the fulfillment of all ADA (Americans with Disabilities Act) requirements.

2.7 All products must be new and unused, unless otherwise specified, in first-class condition and of current manufacture. Obsolete products, including products or any parts not compatible with existing hardware/software configurations will not be accepted.

2.8 Vendor/Contractor/Provider shall provide any and all notices as may be required under the Drug-Free Work Place Act of 1988, 28 CFR Part 67, Subpart F, to its employees and all sub-contractors to insure that Collin County maintains a drug-free work place.

2.9 Vendor/Contractor/Provider shall defend, indemnify and save harmless Collin County and all its officers, agents and employees and all entities, their officers, agents and employees who are participating in this contract from all suits, claims, actions, damages (including personal injury and or property damages), or demands of any character, name and description, (including attorneys' fees, expenses and other defense costs of any nature) brought for or on account of any injuries or damages received or sustained by any person, persons, or property on account of Vendor/Contractor/Provider's breach of the contract arising from an award, and/or any negligent act, error, omission or fault of the Vendor/Contractor/Provider, or of any agent, employee, subcontractor or supplier of Vendor/Contractor/Provider in the execution of, or performance under, any contract which may result from an award. Vendor/Contractor/Provider shall pay in full any judgment with costs, including attorneys' fees and expenses which are rendered against Collin County and/or participating entities arising out of such breach, act, error, omission and/or fault.

2.10 If a contract, resulting from a Collin County IFB, RFP, RFQ, CSP, Quotation is for the execution of a public work, the following shall apply:

2.10.1 In accordance with V.T.C.A. 2253.021, a governmental agency that makes a public work contract with a prime contractor shall require the contractor, before beginning work, to execute to the governmental entity a Payment Bond if the contract is in excess of \$25,000.00. Such bond shall be in the amount of the contract payable to the governmental entity and must be executed by a corporate surety in accordance with Section 1, Chapter 87, Acts of the 56th Legislature, Regular Session, 1959 (Article 7.19-1 Vernon's Texas Insurance Code).

2.11 Purchase Order(s) shall be generated by Collin County to the vendor. Collin County will not be responsible for any orders placed/delivered without a valid purchase order number.

2.12 The contract shall remain in effect until any of the following occurs: delivery of product(s) and/or completion and acceptance by Collin County of product(s) and/or service(s), contract expires or is terminated by either party with thirty (30) days written notice prior to cancellation and notice must state therein the reasons for such cancellation. Collin County reserves the right to terminate the contract immediately in the event the Vendor/Contractor/Provider fails to meet delivery or completion schedules, or otherwise perform in accordance with the specifications. Breach of contract or default authorizes the County to purchase elsewhere and charge the full increase in cost and handling to the defaulting Vendor/Contractor/Provider.

2.13 Collin County Purchasing Department shall serve as Contract Administrator or shall supervise agents designated by Collin County.

2.14 All delivery and freight charges (FOB Inside delivery at Collin County designated locations) are to be included as part of the bid/quote/proposal price. All components required to render the item complete, installed and operational shall be included in the total bid/quote/proposal price. Collin County will pay no additional freight/delivery/installation/setup fees.

2.15 Vendor/Contractor/Provider shall notify the Purchasing Department immediately if delivery/completion schedule cannot be met. If delay is foreseen, the Vendor/Contractor/Provider shall give written notice to the Purchasing Agent. The County has the right to extend delivery/completion time if reason appears valid.

2.16 The title and risk of loss of the product(s) shall not pass to Collin County until Collin County actually receives and takes possession of the product(s) at the point or points of delivery. 2.17.2 Vendor's/Contractor's/Provider's Name, Address and Tax Identification Number;

2.17.3 Detailed breakdown of all charges for the product(s) and/or service(s) including applicable time frames.

2.18 Payment will be made in accordance with V.T.C.A., Government Code, Title 10, Subtitle F, Chapter 2251.

2.19 All warranties shall be stated as required in the Uniform Commercial Code.

2.20 The Vendor/Contractor/Provider and Collin County agree that both parties have all rights, duties, and remedies available as stated in the Uniform Commercial Code.

2.21 The Vendor/Contractor/Provider agree to protect Collin County from any claims involving infringements of patents and/or copyrights.

2.22 The contract will be governed by the laws of the State of Texas. Should any portion of the contract be in conflict with the laws of the State of Texas, the State laws shall invalidate only that portion. The remaining portion of the contract shall remain in effect. The contract is performable in Collin County, Texas.

2.23 The Vendor/Contractor/Provider shall not sell, assign, transfer or convey the contract, in whole or in part, without the prior written approval from Collin County.

2.24 The apparent silence of any part of the specification as to any detail or to the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices are to prevail. All interpretations of the specification shall be made on the basis of this statement.

2.25 Vendor/Contractor/Provider shall not fraudulently advertise, publish or otherwise make reference to the existence of a contract between Collin County and Vendor/Contractor/Provider for purposes of solicitation. As exception, Vendor/Contractor/Provider may refer to Collin County as an evaluating reference for purposes of establishing a contract with other entities.

2.26 The Vendor/Contractor/Provider understands, acknowledges and agrees that if the Vendor/Contractor/Provider subcontracts with a third party for services and/or material, the primary Vendor/Contractor/Provider (awardee) accepts responsibility for full and prompt payment to the third party. Any dispute between the primary Vendor/Contractor/Provider and the third party, including any payment dispute, will be promptly remedied by the primary vendor. Failure to promptly render a remedy or to make prompt payment to the third party (subcontractor) may result in the withholding of funds from the primary Vendor/Contractor/Provider by Collin County for any payments owed to the third party.

2.27 Vendor/Contractor/Provider shall provide Collin County with diagnostic access tools at no additional cost to Collin County, for all Electrical and Mechanical systems, components, etc., procured through this contract.

2.28 Criminal History Background Check: If required, ALL individuals may be subject to a criminal history background check performed by the Collin County's Sheriff's Office prior to access being granted to Collin County. Upon request, Vendor/Contractor/Provider shall provide list of individuals to Collin County Purchasing Department within five (5) working days.

2.29 Non-Disclosure Agreement: Where applicable, vendor shall be required to sign a non-disclosure agreement acknowledging that all information to be furnished is in all respects confidential in nature, other than information which is in the public domain through other means and that any disclosure or use of same by vendor, except as provided in the contract/agreement, may cause serious harm or damage to Collin County. Therefore, Vendor agrees that Vendor will not use the information furnished for any purpose other than that stated in contract/agreement, and agrees that Vendor will not either directly or indirectly by agent, employee, or representative disclose this information, either in whole or in part, to any third party, except on a need to know basis for the purpose of evaluating any possible transaction. This agreement shall be binding upon Collin County and Vendor, and upon the directors, officers, employees and agents of each.

2.30 Vendors/Contractors/Providers must be in compliance with the Immigration and Reform Act of 1986 and all employees specific to this solicitation must be legally eligible to work in the United States of America.

2.31 Certification of Eligibility: This provision applies if the anticipated Contract exceeds \$100,000.00 and as it relates to the expenditure of federal grant funds. By submitting a bid or proposal in response to this solicitation, the Bidder/Quoter/Offeror certifies that at the time of submission, he/she is not on the Federal Government's list of suspended, ineligible, or debarred contractors. In the event of placement on the list between the time of bid/proposal submission and time of award, the Bidder/Quoter/Offeror will notify the Collin County Purchasing Agent. Failure to do so may result in terminating this contract for default.

2.32 Notice to Vendors/Contractors/Providers delivering goods or performing services within the Collin County Detention Facility: The Collin County Detention Facility houses persons who have been charged with and/or convicted of serious criminal offenses. When entering the Detention Facility, you could: (1) hear obscene or graphic language; (2) view partially clothed male inmates; (3) be subjected to verbal abuse or taunting; (4) risk physical altercations or physical contact, which could be minimal or possibly serious; (5) be exposed to communicable or infectious diseases; (6) be temporarily detained or prevented from immediately leaving the Detention Facility in the case of an emergency or "lockdown"; and (7) subjected to a search of your person or property. 2.33 Delays and Extensions of Time when applicable:

2.33.1 If the Vendor/Contractor/Provider is delayed at any time in the commence or progress of the Work by an act or neglect of the Owner or Architect/Engineer, or of an employee of either, or of a separate contractor employed by the Owner, or by changes ordered in the Work, or by labor disputes, fire, unusual delay in deliveries, unavoidable casualties or other causes beyond the Vendor/Contractor/Provider's control, or by delay authorized by the Owner pending mediation and arbitration, or by other causes which the Owner or Architect/Engineer determines may justify delay, then the Contract Time shall be extended by Change Order for such reasonable time as the Owner/Architect may determine.

2.33.2 If adverse weather conditions are the basis for a Claim for additional time, such Claim shall be documented by data substantiating that weather conditions were abnormal for the period of time and could not have been reasonably anticipated, and that the weather conditions had an adverse effect on the scheduled construction.

NOTE: All other terms and conditions (i.e. Insurance Requirements, Bond Requirements, etc.) shall be stated in the individual IFB/RFQ/RFP/RFI/CSP/Quotation Solicitation documents as Special Terms, Conditions and Specifications.

3.1.1 Commercial General Liability insurance at minimum combined single limits of (\$500,000 per-occurrence and \$1,000,000 general aggregate) for bodily injury and property damage, which coverage shall include products/completed operations, independent contractors, and contractual liability each at \$500,000 per occurrence. Coverage must be written on an occurrence form.

3.1.2 Workers Compensation insurance at statutory limits, including employer's liability coverage at minimum limits. In addition to these, the contractor must meet each stipulation below as required by the Texas Workers Compensation Commission; (Note: If you have questions concerning these requirements, you are instructed to contact the TWCC at (512)440-3789).

3.1.2.1 Definitions: Certificate of coverage ("certificate"); A copy of a certificate of authority of self-insure issued by the commission, or a coverage agreement (TWCC-81, TWCC-82, TWCC-83, OR TWCC-84), showing statutory workers compensation insurance coverage for the person's or entity's employees providing services on a project, for the duration of the project.

Duration of the project includes the time from the beginning of the work on the project until the contractor's/person's work on the project has been completed and accepted by the governmental entity.

Persons providing services on the project ("subcontractor" in 406.096) includes all persons or entities performing all or part of the services the contractor has undertaken to perform on the project, regardless of whether that person has employees. This includes, without limitation, independent contractors, subcontractors, leasing companies, motor carriers, owner-operators, employees of any such entity, or employees of any entity which furnishes persons to provide services on the project. "Services" include, without limitation, providing, hauling, or delivering equipment or materials, or providing labor, transportation, or other service related to a project. "Services" does not include activities unrelated to the project, such as food/beverage vendors, office supply deliveries, and delivery of portable toilets.

3.1.2.2 The contractor shall provide coverage, based on proper reporting of classification codes and payroll amounts and filing of any coverage agreements, which meets the statutory requirements of Texas Labor Code, Section 401.011(44) for all employees of the contractor providing services on the project, for the duration of the project.

3.1.2.3 The Contractor must provide a certificate of coverage to the governmental entity prior to being awarded the contract.

3.1.2.4 If the coverage period shown on the contractor's current certificate of coverage ends during the duration of the project, the contractor must, prior to the end of the coverage period, file a new certificate of coverage with the governmental entity showing that coverage has been extended.

3.1.2.5 The contractor shall obtain from each person providing services on a project, and provide to the governmental entity:

3.1.2.5.1 A certificate of coverage, prior to that person beginning work on the project, so the governmental entity will have on file certificates of coverage showing coverage for all persons providing services on the project; and

3.1.2.5.2 no later than seven days after receipt by the contractor, a new certificate of coverage showing extension of coverage, if the coverage period shown on the current certificate of coverage ends during the duration of the

project.

3.1.2.6 The contractor shall retain all required certificates of coverage for the duration of the project and for one year thereafter.

3.1.2.7 The contractor shall notify the governmental entity in writing by certified mail or personal delivery, within 10 days after the contractor knew or should have known, of any change that materially affects the provision of coverage of any person providing services on the project.

3.1.2.8 The contractor shall post on each project site a notice, in the text, form and manner prescribed by the Texas Workers Compensation Commission, informing all persons providing services on the project that they are required to be covered, and stating how a person may verify coverage and report lack of coverage.

3.1.2.9 The contractor shall contractually require each person with whom it contracts to provide services on a project, to:

3.1.2.9.1 Provide coverage, based on proper reporting of classification codes and payroll amounts and filing of any coverage agreements, which meets the statutory requirements of Texas Labor Code, Section 401.011(44) for all of its employees providing services on the project, for the duration of the project;

3.1.2.9.2 Provide to the contractor, prior to that person beginning work on the project, a certificate of coverage showing that coverage is being provided for all employees of the person providing services on the project, for the duration of the project;

3.1.2.9.3 Provide the contractor, prior to the end of the coverage period, a new certificate of coverage showing extension of coverage, if the coverage period shown on the current certificate of coverage ends during the duration of the project;

3.1.2.9.4 Obtain from each other person with whom it contracts, and provide to the contractor:

3.1.2.9.4.1 A certificate of coverage, prior to the other person beginning work on the project; and

3.1.2.9.4.2 A new certificate of coverage showing extension of coverage, prior to the end of the coverage period, if the coverage period shown on the current certificate of coverage ends during the duration of the project;

3.1.2.9.5 Retain all required certificates of coverage on file for the duration of the project and for one year thereafter;

3.1.2.9.6 Notify the governmental entity in writing by certified mail or personal delivery, within 10 days after the person knew or should have known, of any change that materially affects the provision of coverage of any person providing services on the project; and

3.1.2.9.7 Contractually require each person with whom it contracts, to perform as required by paragraphs 3.1.2.1 through 3.1.2.7, with the certificates of coverage to be provided to the person for whom they are providing services.

3.1.2.10 By signing this contract or providing or causing to be provided a certificate of coverage, the contractor is representing to the governmental entity that all employees of the contractor who will provide services on the project will be covered by workers compensation coverage for the duration of the project, that the coverage will be based on proper reporting of classification codes and payroll amounts, and that all

coverage agreements will be filed with the appropriate insurance carrier or, in the case of a self-insured, with the commission's Division of Self-Insurance Regulation. Providing false or misleading information may subject the contractor to administrative penalties, criminal penalties, civil penalties, or other civil actions.

3.1.2.11 The contractor's failure to comply with any of these provisions is a breach of contract by the contractor which entitles the governmental entity to declare the contract void if the contractor does not remedy the breach within ten days after receipt of notice of breach from the governmental entity.

3.1.3 Commercial Automobile Liability insurance shall be no less than \$500,000 combined single limits per accident for bodily injury and property damage, including owned, non-owned, and hired vehicle coverage.

3.1.4 Professional Liability Insurance at minimum limits of \$1,000,000. This policy must have a two (2) year extended period of coverage, (i.e. tail coverage). If you choose to have project coverage endorsed onto your base policy, this would be acceptable.

3.2 The required limits may be satisfied by any combination of primary, excess or umbrella liability insurances, provided the primary policy complies with the above requirements and the excess umbrella is following form. The vendor may maintain reasonable and customary deductibles, subject to approval by Collin County.

3.3 With reference to the foregoing insurance requirement, the vendor shall endorse applicable insurance policies as follows:

3.3.1 A waiver of subrogation in favor of Collin County, its officials, employees, volunteers and officers shall be contained in the workers compensation coverage.

3.3.2 The vendor's insurance coverage shall name Collin County as additional insured under the General Liability policy.

3.3.3 All insurance policies shall be endorsed to require the insurer to immediately notify Collin County of any decrease in the insurance coverage limits.

3.3.4 All insurance policies shall be endorsed to the effect that Collin County will receive at least thirty (30) days notice prior to cancellation, non-renewal or termination of the policy.

3.3.5 All copies of Certificates of Insurance shall reference the project/contract number.

3.4 All insurance shall be purchased from an insurance company that meets the following requirements:

3.4.1 A financial rating of B+VI or better as assigned by the BEST Rating Company or equivalent.

3.5 Certificates of Insurance shall be prepared and executed by the insurance company or its authorized agent, and shall contain provisions representing and warranting the following:

3.5.1 Sets forth all endorsements and insurance coverage's according to requirements and instructions contained herein.

3.5.2 Sets forth the notice of cancellation or termination to Collin County.

4.0 SPECIAL CONDITIONS AND SPECIFICATIONS

4.1 Authorization: By order of the Commissioners' Court of Collin County, Texas sealed bids will be received for: **IFB No. 01165-10, Supplies: Fleet Repair Parts.**

4.2 Purpose: The intended use/purpose for this Invitation For Bid is to describe various parts and supplies for fleet and heavy equipment repair needed by Collin County. Bidders may bid on any/all of the sections of this bid and any/all of the items/manufacturers in each section. Bidders do not have to bid all sections to be considered responsive. Collin County reserves the right to award by section as deemed to be in the best interest of the County.

4.3 Term: Provide for a multi-year contract commencing on the date of the award, and continuing through and including September 30, 2011. Collin County may consider a renewal for (4) four, (1) one year periods based upon the same terms, conditions and pricing as the original year. Renewal is subject to approval by the Commissioners' Court each period. Once the renewal option is exhausted, the contract must be re-bid.

4.4 Funding: Funds for payment have been provided through the Collin County budget approved by the Commissioners' Court for this fiscal year only. State of Texas statutes prohibit the County from any obligation of public funds beyond the fiscal year for which a budget has been approved. Therefore, anticipated orders or other obligations that may arise past the end of the current Collin County fiscal year shall be subject to budget approval.

4.5 Price Reduction: If during the life of the contract, the vendor's net prices to its customers for the same product(s) and/or services shall be reduced below the contracted price, it is understood and agreed that the County shall receive such price reduction.

4.6 Price Re-determination: A price re-determination may be considered by Collin County only at the twelve (12) month and twenty-four (24) month and thirty-six (36) month anniversary dates of the contract. All requests for price re-determination shall be in written form and shall include documents supporting price re-determination such as Manufacturer's direct cost, postage rates, Railroad Commission rates, Federal/State minimum wage law, Federal/State unemployment taxes, F.I.C.A, Insurance Coverage Rates, etc.. The bidder's past experience of honoring contracts at the bid price will be an important consideration in the evaluation of the lowest and best bid. Collin County reserves the right to accept or reject any/all of the price re-determination as it deems to be in the best interest of the County.

4.7 Delivery Time: Due to various needs of the County, items have two (2) options for delivery time as stated below. Bidders may bid on one or both options. Delivery time for all other sections of the bid shall follow requirements of Standard Delivery.

4.7.1 Standard Delivery: Delivery time for vendor stocked items shall be twenty-four (24) hours ARO and vendor non-stocked items shall be seventy-two (72) hours ARO. Generally, this includes all parts/supplies needed for the County's parts inventory stock, or items that are not immediately needed for repair of downed vehicles or equipment. Delivery/turn-around time for rebuilt items shall be twenty-four (24) hours.

4.7.2 Immediate Need: Vendor shall deliver part(s) to the County's designated location within one (1) hour after notification from the County for vendor stock items that are determined, by the County, to be needed immediately in order to repair a piece of downed equipment or vehicle. Vendor shall stock parts for which they are submitting bids under this option, or shall be able to obtain the part from an alternate source in order to provide the needed repair part to Collin County within the designated time frame.

4.8 Delivery Hours: All "Standard" deliveries shall be between the hours of 7:00 a.m. and 2:00 p.m. "Immediate" deliveries shall be delivered as ordered.

4.9 Delivery Location: Unless otherwise stated, all items bid shall be delivered to the Collin County Service Center, 700A Wilmeth Road, McKinney, Texas 75069 (*Mapsco page 261T*). On occasion, Immediate Delivery items may require the vendor to deliver the repair part(s) to a field site repair location within Collin County rather than the Services Center.

4.10 Samples: When requested, samples shall be furnished to the County at no expense.

4.11 Approximate Usage: The total estimated annual expenditure for Collin County is \$250,000. Estimated expenditure does not constitute an order, but only implies the probable quantity the County will use. Commodities will be ordered on an as-needed basis.

4.12 County Fleet: The County fleet is presently comprised of light & medium duty trucks, passenger cars, vans, 2WD & 4WD sport utility vehicles, heavy trucks, off-road heavy equipment, tractors, mowers, utility and equipment trailers, landscape equipment and various other equipment such as welders, generators, compressors, etc., for which replacement parts may be needed.

4.13 Submittals: Bidder shall submit, and it shall become a part of the bid and subsequent contract, a current catalog(s)/line sheet(s)/computer printout/jobber, along with current price sheets and any cross reference material to assist in the evaluation of the bid, for parts/supplies available to the County, to which the percentage discount shall be applied. Failure to provide proper material with this IFB for determining price and cross referencing part numbers may result in rejection of the bid or that part of the bid. Vendor may upload the current catalog(s)/line sheet(s)/computer printout/jobber to BidSync or they may submit a hard copy of the bid information to the: Collin County Purchasing Department located at: Collin County Administration Building, 2300 Bloomdale Road, Ste. 3160, McKinney, TX 75071.

4.14 Bid Pricing:

4.14.1 Most items on this bid are divided into two (2) sections. Section I will be a list of general use items. Bidder shall provide pricing for each of the items on the list. This pricing shall remain consistent throughout the term of the contract or until such time that a price re-determination is granted in accordance with section 4.6. Pricing for this part should reflect the percentage discount given in Section II. Pricing and percentage discount for standard delivery as well as immediate delivery is requested for each part under this section. Section II will be for bidder to provide a percentage discount from the bidder's/manufacture's current published catalog(s)/line sheet(s)/computer printout/jobber for items in that section. The percentage discount shall remain consistent throughout the contract period. Bidder shall state what pricing structure the percentage discount should be applied to (i.e. list, jobber, retail, etc.). **Bidder should only submit bids for immediate delivery if the vendor will be able to meet the one (1) hour delivery requirement.**

4.14.2 For the following sections of the bid,

- q OEM Parts for Light Duty Truck, Passenger Car and Van Parts
- q OEM Parts - Medium & Heavy Duty Over-the-Road Truck Parts

the bidder shall provide a percentage discount from the bidder's/manufacture's current published catalog(s)/line sheet(s)/computer printout/jobber for items listed in those sections.

4.15 Evaluation and Award:

4.15.1 Bids will be awarded to the overall low bidder for each delivery option under each category (i.e. Passenger Cars, Vans, Light Duty Trucks would be considered a category). Collin County anticipates awarding to both a primary and

secondary vendor under Immediate Delivery for each category. Should there be an occasion where the primary vendor does not have the needed repair part available or cannot deliver the part within one (1) hour, Collin County will go to the secondary vendor for the part. Percentage discount will be evaluated by applying the percentage discount to a pre-determined list of parts/supplies pulled from the bidder's catalog and will constitute 40% of the bid evaluation. The price comparison list will constitute 60% of the bid evaluation.

4.15.2 All other sections will be awarded separately based upon percentage off current catalog(s)/line sheet(s)/computer printout/jobber suggested list price.

4.16 Additional Reference Materials & Crossover of Part Numbers: Upon award of the contract, the vendor shall furnish one (1) additional set of catalogs/line sheets)/computer printout/jobber including current list prices. Vendor's authorized representative shall, upon award, assist Collin County in "crossing-over" part numbers of parts in the County's existing inventory to the vendor's part numbers.

4.17 Delivered Orders and Returns: Delivered orders shall be separated and separately boxed by purchase order number for delivery. All delivery tickets (packing slips) shall reference the Collin County purchase order number and delivery location as directed by the Purchasing Department. Each delivery ticket (packing slip) shall be consistent with the County's purchase order and show all items placed on order and items delivered. **The vendor guarantees that the County may return any and/or all items purchased within thirty (30) days after delivery for full credit without any re-stocking fees applied (short term return). Substitutions shall be made only as approved by the Purchasing Department.**

4.18 Non-delivered Order/Back-orders: Should the vendor be unable to deliver parts as ordered within the specified time frame, the vendor shall contact the Equipment Services Department (*Bob Upchurch 972-548-3709*) in order to determine if a back-order will be allowed. Inability of the contracted vendor to deliver parts within the time frame specified in this IFB authorizes the County to purchase elsewhere.

4.19 Restocking Policy: The vendor shall, periodically during the term of the contract, allow credit for, replace or exchange parts/supplies purchased during the contract period which have become obsolete for the County's needs, provided that these parts/supplies are in the original cartons and in a sellable condition. Refund or credit for these parts/supplies shall be at current market value, less any restocking fee. Bidder shall state restocking fees, if any, in the space provided on the bid form. Bidder shall state any exceptions to the restocking policy in the space provided. Bidder shall state the time period during which their company will allow parts to be exchanged or returned for credit if Collin County will not be allowed to return parts at the County's convenience.

4.20 Authorized Representative: The vendor shall designate an authorized representative of their firm and/or factory representative to work in conjunction with the Equipment Services Department in regard to factory and merchandise recalls, warranty, catalog updates, brand name and/or mass part number changes, inventory control and any/all changes in the industry that could affect the operation of the County's equipment.

4.21 OEM Parts or Approved Equal: Bids submitted for OEM parts (or approved equal) shall be subject to approval by the Equipment Services Manager. Any bids for non-OEM parts not meeting or exceeding the quality of OEM parts shall be rejected.
