GENERAL DISCUSSION

5. Al-32012 Constables' duties, Constable, Precinct 3.

Chuck Presley, Constable Precinct 3, addressed the Court to discuss the duties of his office. Constable Presley stated he had this item placed on the agenda to discuss the role of the Constable in Collin County from the Court's perspective as well as his own. He gave a brief history of his observations of a Constable's duties and how they assist other law enforcement agencies when needed. Constable Presley continued saying he budgeted for equipment and he feels that a deputy constable should be as equally equipped as a deputy sheriff. Constable Presley stated the patrol vehicles needed to be well equipped to protect the deputies and the citizens they serve. He continued saying he pulled a request for M.D.C.s (Mobile Data Computers) for patrol cars from his budget so he could meet a flat budget this year; he will try to get grant funding instead. Commissioner Hoagland said he would like to see the cost of the requested equipment compared to revenue when it is time to make decisions on the request. A brief discussion with the Court followed. (Time: 6:31 p.m.)

6. <u>Al-31937</u> Accept the donation of various items from deputies in the Constable, Precinct 4 office, Constable, Precinct 4.

Constable Johnny Todd, Constable Precinct 4, approached with comments regarding his precinct working traffic patrol.

Constable Todd then reviewed the list of items submitted for approval of acceptance and told the Court the items he really needed the most was the mobile vision cameras and the laptop computer. Judge Self asked if the cameras were for the protection of his deputies. Constable Todd relied yes, not only are they for protection of the deputies they also protect the public because they record both video and sound. Constable Todd then informed the Court that the laptop would require an air card in order to use it in a vehicle. The laptop would enable the deputy to perform duties while in the field rather than have to come in to the office and use the computer. Judge Self asked Caren Skipworth if the computer will integrate with the County system. Caren Skipworth, IT, approached saying yes, the laptop would integrate and did not have an issue with supplying an air card. Motion to approve acceptance of mobile vision cameras and laptop. (Time: 6:38 p.m.)

Bill Bilyeu, County Administrator, introduced David Medanich, First Southwest. Mr. Medanich addressed the Court with an update on the county's finances and a projected restructure of debt service. Judge Self asked if the rates shown were better or if the County would be pushing the debt to the future. Mr. Medanich replied that the rates were slightly better; the rates are low, but it would be funded over a longer period of time.

Commissioner Jaynes asked what \$21 million in issued debt represented. Ruben Delgado, Engineering, responded saying it was to keep some projects on schedule. Tracey Homfeld, Engineering informed the Court a spreadsheet had been sent that projected the needs through 2011. Jeff May answered questions from Judge Self regarding the Truths In Taxation Report which is typically due the first week in August. Mr. May also stated if the county were to refinance, it needed to be done immediately in order to change the tax rate. Mr. Medanich added it should take about 60 days for the refinance. The Court had a brief discussion on their options. Commissioner Jaynes requested a list of the cities' projects. (Time: 6:52 p.m.)

8. FY2011 Budget Update:

a. AI-32088 Preliminary Budget Presentation, Budget.

Monika Arris, Budget, gave a power point presentation on the FY 2011 Budget outlook. Ms. Arris gave the court estimated figures and early projections for the upcoming budget. The data included average home values and estimated tax bills as well as estimated tax revenues. It is estimated that 2% or about \$3 million will not be spent through the end of FY 2010; therefore, it will be placed back into the general fund. There will be an estimated \$8 million decline in expenditures for the FY 2011 budget year. Next, employee benefits and the Pay for Performance (PFP) program were discussed. A 1% increase in county employee wages would cost \$791,000, a 1.5% increase would cost \$1.19 million and 2.0% increase would cost \$1.6 million from the general fund. Transfers were discussed next; Ms. Arris explained these are funds that are taken from the general fund in order to keep some county departments on a flat budget.

The presentation also included a five year plan assuming no changes in the tax rate and funding the unfunded liability. The projection extended to FY 2015. Discussion with the Court continued thorough out the presentation. Commissioner Shaheen wanted to see comparisons with the private sector on benefit costs. Judge Self agreed saying the county needed to compare what the county employee received as compared to what its citizens received. Commissioner Ward stated they needed to get the legislation on changing the retirement contribution by adopting a two tier program. Commissioner Hoagland stated he did not want to cut the tax rate because bonds cannot be sold now.

The presentation included a separate projection for each of the county's operating funds. Dates were suggested for the budget workshop as well as the two required public hearings. The first hearing is scheduled for August 30, 2010. The second hearing is scheduled for September 7, 2010 and adoption of the FY 2011 budget is scheduled to be on the September 13, 2010 Commissioners' Court agenda.

Commissioner Ward asked Ms. Arris to look at cutting travel and other costs that would enable a 1.5% increase for PFP. (Time: 7:24 p.m.)

b. AI-32135 District Judge Rusch, Auditor.

Judge Mark Rusch, 401 District Court and Administrative Judge for Collin County District Courts addressed the Court with comments regarding the tight budget and stated the county still needed to continue providing services to the citizens. Judge Rusch introduced a presentation to be given by Jeff May with recommendations that he thinks will close the budget gap without taking away any services from the county.

Jeff May, County Auditor, gave a power point presentation that included an estimate of loss in revenues and 10 recommendations that would balance the budget and create a surplus in the general fund. Mr. May stated the county's current practice is to budget for expenditures that will take place in the future. Discussion with the court continued throughout the presentation. The recommendations are as follows:

- 1) Change budget procedure for non-departmental contingencies-\$5.6 million
- 2) Reduce non-departmental maintenance and maintenance contract budgets-\$2.2 million
- 3) Utilize District Attorney's office for legal advice-\$500,000
- 4) Reduce various non-departmental accounts that are under-utilized-\$1.1 million
- 5) Restructure capital replacement budgeting-\$600,000
- 6) Reallocate Road and Bridge tax revenue-\$3.9 million
- 7) Reduce the unemployment insurance premium by 75%-\$250,000
- 8) Combine county building maintenance departments into one department-\$500,000
- 9) Reduce cell phone budget-\$200,000
- 10) County Auditor budget reduction-\$150,000

The total savings for the county is an estimated \$15 million.

Frank Ybarbo, Purchasing Agent, approached the Court with his department's recommendations which added an additional savings of an estimated \$1.08 million. These recommendations included review and adjustments to maintenance agreements, replacement vehicles, furniture expenditures and supplying coffee for county employees.

When asked how his figures were obtained Mr. May replied he had 14 years experience in the auditor's office and has seen funds budgeted that were not needed or over budgeted. Mr. May also stated the numbers shown did not include staff hours spent to process expenditures that could be reduced. Mr. May expressed his concerns about cutting taxes because it is unknown what may happen economically when the new federal requirements become effective. (Time: 7:45 p.m.)

Judge Self recessed the meeting at 7:46 p.m. and reconvened at 7:52 p.m.

c. AI-32116 TEX-21 Membership.

Judge Self gave comments regarding the cost of membership to belong to the organization and does not recommend further participation. He stated the county's objective can be accomplished without the membership and \$17,000 could be saved. Judge Self said this will be brought back for discussion during the budget talks. This item will be placed on an agenda with other memberships that need to be reviewed. (Time: 7:53 p.m.)

d. Al-32190 PFP program for FY2011, County Judge.

This program was addressed during the budget presentation. The Court had a brief discussion about a Bureau of Labor Statistics survey, which compared salaries of private industry employees and Collin County employees. Commissioner Hoagland stated there was an issue with the County paying insurance for spouses and children. Commissioner Hoagland feels the County has an obligation to the employees not the spouses at the current level that is being paid. The Court had an extensive discussion regarding the costs of benefits.

Motion to approve 1.5% for PFP increases by Commissioner Jaynes, Seconded by Commissioner Hoagland. Motion failed 2-3 (Time: 7:19 p.m.)

After the vote was taken, Judge Self asked about a market survey of county salaries as compared to other public sector jobs. Cynthia Jacobson, Human Resources responded saying the person responsible for compensation had left the county's employment, so her department had not compiled the survey. Ms. Jacobson also stated she had not planned to conduct a market study this year because she did not expect to get PFP increases; she thought any increases would be budget based. After a brief discussion with the Court, it was decided that the study would not be completed this year, but would be done next year. (Time: 8:04 p.m.)

Judge Self gave an update saying the NTTA has asked for input from the RTC; however there will not be a vote, just input. Judge Self continued saying the county needed a strong advocate at the RTC meeting on Thursday and suggested the Court vote a member as representative. The Judge and the City of Celina will give a briefing during a meeting on July 21, 2010. As of today, there will be a decision on the alignment during that meeting. Collin County and Celina will make a proposal that will be worth an estimated \$100 million to the NTTA. The proposal will include a request for the NTTA to build in an area that will be populated in 30 years so that tolls can be paid. Discussion among Court members followed the update. (Time: 8:12 p.m.)

Jeff Durham, Special Projects, addressed the court with information on the Veterans Memorial Wall project. There are approximately \$850,000 in bond funds are available to fund the remaining \$300,000 needed for the project. There was a brief discussion with the Court on the funding.
