Commissioner Jaynes gave comments on the selection of the polling places and stated he was glad the John and Judy Gay Library had been added for the convenience of McKinney voters and said he would like it to replace Fire Station No. 7.

Commissioner Jaynes continued saying he would like to have the library as a location for all future early voting and would like to hear the benefits of the library versus the fire station. Vicki Self, Elections, replied to Commissioner Jaynes' comments saying the reason the library was not added as a full time polling location is because it is not a full time library and is not always open. Commissioner Shaheen thanked Elections for adding the Frisco location. Motion to call the November 2, 2010 General Election.

GENERAL DISCUSSION

5. <u>AI-32384</u> CUC Tech Share, CIJS & JCMS update presented by Charles Gray and acceptance of the CIJS rebate check in the amount of \$78,855, Information Technology.

Caren Skipworth, Information Technology, opened the discussion by introducing Charles Gray of the Texas Conference of Urban Counties (CUC) and informed the court of the acceptance of a rebate check from the County's initial involvement with the CIJS project. These funds have been deposited back into the CIJS project funds to be used for other initiatives.

Charles Gray, CUC, gave a power point presentation and provided an update of the Techshare program. There are three (3) projects at the CUC related to technology. Common Integrated Justice System (CIJS), the Juvenile Case Management System which is a new collaboration with the State and an Adult Case Management System will is scheduled to begin soon. The update included a brief overview of the program which was formed in 2004 in order to enable counties to collaborate on information technology projects while also saving money; the goal of the program is to provide better systems at lower costs to the counties.

Mr. Gray continued with an update on CIJS saying the program began providing license fee rebates in 2009 and to date has rebated nearly one million dollars back to the participating counties. Currently there are 15 counties enrolled in the program and the contract has been extended until 2014. The CIJS contract includes all court types and so far criminal, which is the most difficult to implement, is the only court type not yet in Collin County. CIJS offers optional modules which include law enforcement, jail, check processing and adult probation. A list of the participating counties was shown to the court with the most recent to join being El Paso County. Tarrant and Travis counties are currently looking at the system.

Mr. Gray then gave an overview of the newly developed Juvenile Case Management Justice System (JCMS), which is one system for all Texas counties. This system will replace the system currently in use and will be funded by the State. Additional modules will be available should the counties want to the share cost of implementation. All participating counties will share the data in accordance with the Family Code. Collin County will have the choice of implementing the new JCMS basic case management system, or keep Odyssey which it is already using. Additional information regarding the new JCMS was given to the court.

Commissioner Shaheen gave comments saying it is good for counties to share information; to see what is working and what is not. A brief discussion regarding the benefits of the program followed. Mr. Gray then gave the court an overview of the Adult Case Management System (ACMS).

Mr. Gray informed the Court the county would be invited to join the project. This would be a 12 week project and would consist of three steps. First, they would draft rules for criminal justice in order to enable electronic filing (e-filing) for criminal cases. Currently in Texas e-filing is only accepted for civil cases. Second, there will be an update to the plan for CIJS and third, a software development project; the type of development will be decided by the counties who participate.

All CUC members will be invited to participate in one of two levels. Planning, in which they would share in the planning costs, and full participation which would be committed to developing the Criminal Justice module. The total cost for the project will be approximately \$100,000. This cost will be split between the participating counties. Mr. Gray informed the court that due to Caren Skipworth's duties as chair of the technical committee, the county will be able to participate in the project without having to commit to the project.

Commissioner Shaheen asked why a cost was associated with the program. Mr. Gray replied the cost covers the fee for a consulting firm to assist in drafting the rules and updating the plan as well as exposing them to initiatives that are going on in other states. The period for the project will be from October 2010 to November 2011.

Judge Self asked what size counties will join the program. Mr. Gray replied there are smaller counties that are interested because they can use the system without having to host it; they can accept the standard configuration which has been done by other counties and just take training. The cost would be very low and that is attractive to them. After a brief discussion with the court, Judge Self thanked Mr. Gray for the information. (Time: 10:01 a.m.)
