Judge Self called to order the meeting of the Collin County Commissioners Court at 5:58 p.m. Judge Self thanked the City of Melissa for hosting tonight's meeting and stated the Commissioners held meetings once each quarter in order to offer themselves to the citizens in various areas across the county. Judge Self recessed into the meeting of Collin County Health Care Foundation at 6:02 p.m.

#### **FYI NOTIFICATION**

- 2. Public Comments. Judge Self asked if there were any blue cards for public comment. Roy Serpa, Fairview, came forward with comments on the salary survey requested by Commissioner Jaynes. Mr. Serpa strongly recommended that when the survey is conducted it is a compensation survey, not a salary survey. Compensation means salary plus benefits. Mr. Serpa also recommended that the Court compare not only to private sector personnel but compare to public comparable personnel as well. Mr. Serpa continued saying they needed to be aware of how many reclassifications had been made in the last five years and stated he would like to know how many had been made. Mr. Serpa told the Court he would appreciate this information being made available to the taxpayers. (Time: 6:01 p.m.)

Chuck Molyneaux, gave comments on employee reclassifications saying any position that does not require a high school diploma, typing test or any other certifications or qualifications and that has a minimum salary of \$46,000 and a maximum salary of \$75,000 requires re-evaluation. The taxpayers want to know what the qualifications are for other positions in the same pay range. It appears Collin County is being very generous hiring GED accredited employees into a position that starts at \$46,426 and has a maximum of over \$74,000. We strongly recommend comparison of positions requiring minimum educational requirements to those positions requiring hiring level of education degrees; if no college accreditation is required, no special training is required, or there is no defined accreditation required then the salary ranges of these positions warrant a lower pay range than those accredited or specially trained employees. Our questions to you are what are the qualifications of other positions in the same pay range and what is the normal pay range for a person without a high school diploma and without any certifications. (Time: 6:22 p.m.)

Mark Reid, Plano, gave comments on reclassifications saying he echoes the previous speaker's comment in that the salary range appears to be high. Mr. Reid while he was not an expert, he does run a commercial construction company and said he pulled some information from a 2009 salary survey to take a look at what comparable positions in the construction industry might pay. He gave an example of a Field Engineer I that requires three to five years experience with no specific degree or certification is \$25,000 to \$62,000. A Field Engineer II requires five to seven years experience and has a pay range of \$33,000 to \$68,000. A Project Accountant I with routine administrative and payroll activities, a non-degreed employee with up to five years of general office experience is \$24,000 to \$50,000 with the fiftieth percentile at \$33,000.

If you go up to Accountant level III a non-degreed employee with up to 10 years experience pays \$32,000 to \$79,000. At a level IIII a bachelors' degree in accounting is required and the range goes to \$40,000 to \$73,000. Mr. Reid continued saying he hoped the information was helpful and that this is a very sensitive issue for the court and the employees as well. He stated that the salary range on this position did seem to be high. Commissioner Ward requested copies of the survey for the court and Human Resources. (Time: 6:26 p.m.)

Judge Self recognized two additional blue cards for public comment. After the additional public comments were heard, Judge Self returned to this item to discuss the reclassification of the Court Coordinator position.

Judge Self agreed with Commissioner Hoagland who believes salary studies should not be up to the taxpayer or a judge. but rather the Human Resources department. Commissioner Hoagland stated that the county has a Human Resources department and that is who the court should rely on for these studies. Judge Self agreed saying the county tended to keep these decisions in house such as with the Information Technology (IT) department. There is a consolidated IT department, not one for each separate department; we also have a consolidated HR department that does the county's salary studies on a routine basis. Judge Self asked why the high range considering the qualifications. Cynthia Jacobson, Human Resources, responded saying the higher range was a discussion between court and the judges; at the time they were using a range that had the same job title, but was not at a comparable job so it increased the salary level. Judge Self commented that the position did not require a degree and had no supervisory of any sort. Discussion regarding comparable positions, their requirements and what they pay compared to the court coordinator position in Collin County followed.

Judge Self asked about the position in the City of Plano. Ms. Jacobson replied that the City of Plano position supervised another position and the one in the City of McKinney supervised multiple clerks. Judge Self questioned why the county was paying the higher salary. Ms. Jacobson replied the salary was approved by the court following discussion.

Judge Self asked about the other positions in the same pay range and what they require; education, experience, etcetera. Ms. Jacobson stated that in this pay range there is a Law Librarian which requires a Masters degree, a Records Manager which requires a very specific certification before they can take the job and a WIC (Women Infants and Children) Supervisor who supervises 25 staff. Judge Self asked what you say to the people who are getting the same pay but have different requirements. Ms. Jacobson referred to the reclassification sheet and said typically they keep jobs as equal as they can; when a situation arises that needs an adjustment she will bring it before the court. As an example, one of the items on the reclassification sheet was for Kenneth Maun's office. He has positions that were initially high, so they were moved to a lower range to be more consistent with an entry level position.

Commissioner Jaynes stated that it sounded as if the court were dealing with this piecemeal. He suggested a hold on the re-classes until a salary survey could be completed so they could get a clear picture of where the county stood and then take the appropriate action.

Commissioner Shaheen stated he had a request to hold the item for 30 days. Commissioner Jaynes agreed saying 30 days would not make much of a difference. Additional discussion among the court members followed. Commissioner Shaheen asked for clarification on how a re-class impacts the employee. Ms. Jacobson replied a re-class does not move anyone's salary up or down; it just changes the pay range. She checked each employee in this position and no one's salary will be affected. Ms. Jacobson also stated the re-classes are looked at for both an increase in range and a decrease in range; not just an increase as earlier indicated. Judge Self asked for a motion from the court. Commissioner Shaheen made a motion to hold the item for 30 days. Commissioner Hoagland disagreed with the motion. Motion to pull item for 30 days. (Time: 6:39 p.m.)
