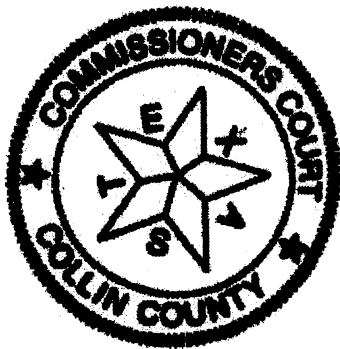


**COURT ORDER NO. 2010-937-11-10**


